

本报告立足于贵州省人大常委会法工委、省高级人民法院、省人民检察院、省政府法制办、省司法厅、省公安厅等有关部门的资料,紧跟贵州省法治建设和依法治省的重大举措,真实反映 2014 年贵州法治发展进程,深刻解读法治进程中的重点、难点和热点问题,深入分析贵州法治发展形势,提出对策建议。

本报告认为,2014年以来,贵州省各级党委、政府牢固坚持依法治国、依法执政、依法行政共同推进,坚持法治国家、法治政府、法治社会一体建设,积极运用法治思维和法治方式谋划、推进法治建设各项工作,把法治贵州建设工作摆到同步建成小康社会的大局中来,作为一项执政为民的实事列入党委的工作重点、列入经济发展规划,切实担负起全面推进法治贵州建设的责任,使地方立法、行政法治、审判检察以及司法行政等领域各项工作取得了长足进步。

针对当前贵州省在法治建设中面临的突出矛盾和问题,根据党的十八届四中全会、贵州省委十一届五次全会对建设法治国家、法治贵州提出的新任务、新要求,本报告提出了进一步推动贵州地方法治建设的对策建议:一是在法治贵州建设中,坚持和完善党的领导,加强党领导方式的制度化,提高法治贵州建设各环节的公众参与度,增加各环节的透明度;二是加强和改进立法工作,完善地方性法规规章,充分发挥立法的引领和推动作用,同时用足用好用活立法自治权,促进民族自治地方经济社会发展;三是就依法行政方面存在的问题,加强法治思维与法治方式的宣教引导,健全依法行政制度建设,推进行政体制改革,整合优化矛盾纠纷调解机制,改进依法行政考核体制及其结果运用,加快提高政府工作的法治化水平;四是牢固树立依法治



理的理念,善于运用法治思维谋划、推进平安建设各项工作,善于运用法治方式研究、解决平安建设面临的问题,努力把平安建设纳人法治化轨道,深入推进平安贵州建设的各项工作;五是在生态建设领域大力推进制度创新,先行先试、大胆探索,力争取得重大突破,为全国生态文明法治化建设积累有益经验。

Abstract

Based on relevant data collected from functional departments including People's Standing Congress Committee of Legal Affairs of Guizhou Province, People's High Court of Guizhou Province, People's Procuratorate of Guizhou Province, Legislative Affairs Office, Justice Department and Public Security Department of Guizhou government, this report is concentrated on the major initiatives of the development of the rule by law and the law-based governance in Guizhou Province. By analyzing the important, difficult and hot issues with a full reflection of the progress in promoting the rule by law in 2014 and predicting future development of the rule by law in Guizhou Province, this report proposes some suggestions.

This report claims that the idea of rule by law has been firmly established and the responsibility of social governance to promote the rule by law has been fully taken by party committees and governments at all levels in Guizhou since 2014. By the logic of rule by law, progress has been made in building Guizhou under the rule of law. Based on scientific, democratic and legal ruling, building law-ruled Guizhou has been considered as a major task involving scientific development. As an example of governing for the people, building Guizhou under the rule of law has been treated as the focus of party committees and has been listed in economic development program. Great progress has been made in fields of local legislation, administrative government by law, judicial adjudication, procuratorial work and judicial administration.

Aiming at the current obvious contradictions and problems faced by building law-ruled Guizhou and combining the new task and new request proposed for building a law-ruled country and law-ruled Guizhou by the Eighteen Session of the Fourth Plenary Session of the Communist Party of China and the Eleventh Session of the Fifth Plenary Session of the Guizhou Provincial Party Committee , this

report presents some suggestions on how to further promote the rule by law. First, uphold and improve the leadership of the Party, enhance the institutionalization of leadership pattern, encourage the public to attend the process of building law-ruled Guizhou and increase transparency during the process of building law-ruled Guizhou. Second, strengthen and improve legislative work, improve local laws and regulations, and give a full play to the leading role of legislation. At the same time, take full use of legislative autonomy in a flexible way and enhance the economic and social development in national autonomous areas. Third, in order to adress problem related to law-ruled administration, we should promote the publicity and education about the idea and method of rule by law, improve the institutional building of law-ruled administration, promote the reform of administrative system, integrate and optimize dispute mediation mechanism, improve the examination system and its results of law-ruled administration, and increase the level of law-ruled governce. Fourth, develope a firm attitude toward the idea of rule by law, plan and promote the build of safe Guizhou. When it comes to the problems dur the build of safe Guizhou, we should study and address them by making good use of the method of rule by law, incorporate the build of safe Guizhou into the orbit of rule by law, and make a great effort to build safe Guizhou. Fifth, make a great effort to promote the innovation in institutional building in the filed of ecological construction. By playing a leading and exploratory role, we will make great progress and gather great experience in building law-ruled ecological civilization.
