Brief Introduction of Key Authors

The Research Center is dedicated to the study and research, from a legal perspective, into all aspects of the financial development in Chinese modern economy with a view to announcing/publishing the results of its research thereby, promoting innovation in the theory of law and finance and promoting a healthy growth in the financial sector.

He took charge of more than ten major projects at the provincial or ministry level for the IFB, and was also Chief Editor of four editions of Annual Report on Financial Laws and Regulations of China. He has published over twenty papers in significant legal journals such as Chinese Journal of Law and Finance & trade economics. He has extensive practice experience and expert knowledge in the financial laws and regulations. He was awarded with the "Youth Innovation Award" by Central State Organs Work Committee. 《中国金融法治报告(2009)》由"总报告"、"改革开放三十年中国金融法 治化进程"、"前沿与热点"以及"调研报告"四个部分构成。"总报告"部分 分为两篇:第一篇为"法治愿景下的中国金融改革——中国金融法治化进程回 顾与展望",是将中国金融法治置于改革开放的大背景下,系统地总结了三十年 来中国金融法治的基本脉络、存在问题和发展趋势。第二篇为"全球金融危机 背景下的中国金融法治建设——2007~2008年度综述", 其分析了2007~2008年 度中国金融法治建设情况,特别是在全球金融危机背景下中国政府采取的各项金 融政策和措施,提出了完善金融监管、加强金融立法、积极应对金融危机的政策 建议。"改革开放三十年中国金融法治化进程"部分具体剖析了我国银行、证券 与期货、基金、保险、信托以及外汇管理等领域的法治化进程,认真总结了这三 十年的进展和经验教训, 并从中导出了对于中国未来金融法治建设极为有益的启 示。"前沿与热点"部分包括 2007~2008 年的热点问题分析, 重大案例或事件的 评析,新出台或实施的法律法规对中国金融业的影响分析,以及前沿理论探讨等 方面。热点问题涉及金融危机下的中国金融监管与立法、网络银行交易的风险分 配、私募股权基金、主权财富基金等; 重大案例评析从太平洋证券上市、机动车 强制保险保费争议等事件出发,对中国公司上市制度的创新及其法律边界、机动 车强制保险的模式选择等问题进行了评析:新法评析主要包括《中华人民共和 国物权法》、《中华人民共和国劳动合同法》以及《证券公司监督管理条例》等 的颁布实施对中国金融发展及某些具体制度的影响; 理论探讨则集中在中国公司 债券的发行监管体制、返程投资的外汇管制、赤道原则以及金融控股公司的内部 信息等方面。"调研报告"部分收录了"中国金融法治环境调研报告",该报告 是中国社会科学院金融研究所课题组在对黑龙江省及河北省唐山市进行国情调研 的基础上形成的,是我国金融法治现状的一个区域性标本和缩影。

Annual Report on Financial Laws and Regulations of China 2009 consists of chapters entitled "Overall Reports", "Developments in Financial Laws and Regulations of China in the 30 Years of Reform and Opening-Up", "Frontier Theories and Current Issues" and "Investigation Report".

"Overall Reports" contains two articles: the first article is entitled "Financial Reform of China with the Goal of Rule of Law-Thinking Back and Looking Forward on the Developments in Financial Laws and Regulations of China", and summarizes the basic structure, the existing problems and the trends in developments of the financial laws and regulations of China within the context of the 30 years of Reform and Opening-up. And the second article is entitled "Construction of Financial Laws and Regulations of China during the Financial Crisis: Annual review 2007 – 2008", and analyzes the developments of the financial laws and regulations of China from 2007 to 2008, in particular the measures and policies that the government and administration of China adopted in the global financial crisis aimed at strengthening financial supervision and legislation to resolve certain difficulties arising from the crisis.

In "Developments in Financial Laws and Regulations of China in the 30 Years of Reform and Opening-Up", the authors analyze developments in fields of banking, securities and futures, funds, trusts, insurance and foreign exchange, and summarize historical developments and lessons learned from the past 30 years to gain inspiration for the promotion of the financial laws and regulations of China.

"Frontier Theories and Current Issues" consists of analysis and evaluations of the current issues, frontier theories and major cases, and the impacts of newly promulgated laws and regulations with respect to finance. The current issues relate to the financial supervision and legislation of China in the financial crisis, risk allocation of internet banking transactions, private equity funds and sovereign wealth funds and other issues.

The major cases include the exchange listing of Pacific Securities Co., Ltd. and controversies rising from the compulsory motor vehicle insurance requirement. The authors analyze and evaluate the innovations on the exchange listing regulations of China and the choice of the model for compulsory motor vehicle insurance. The evaluation of new laws and regulations primarily includes the impact of the *Property Law*, the *Labor Contract Law* and the *Regulations of Supervision and Administration on Securities Companies* on the developments of the financial laws and regulations of China and specific government institutions. The study of theories focuses on the supervision system of securities issuances of Chinese companies, foreign exchange administration on round trip investments, the equator principles and the inside information of financial holding companies.

"Investigation Report" includes the "Investigation of the Current Situation of Financial Laws and Regulations of China" which is based on the investigations in Heilongjiang Province and Tangshan Municipality, Hebei Province, completed by a project team of the Institute of Finance & Banking in the Chinese Academy of Social Science and is a regional epitome of current situation of the financial laws and regulations of China.
