前言

編輯說明

一、《世界工商企業指南》于1990年12月由中華人民共和國新聞出版署批准，列入經濟管理出版社八五出版計劃，本書為第二卷《中國卷·大陸分冊》1993，以英文、中文對照形式出版。《指南》是一部集貿易指南、企業名錄為一體，具有開創性和指導性的資料參考書和工具書，較全面、系統地分地區、分國別地介紹世界各主要經濟貿易國的經貿政策、海關法規、投資政策、外匯管制、銀行業務、保險業務及主要工商企業名錄等從事經貿活動所必須掌握的有關內容，直接為海內外經濟貿易、工商、金融等各界人士開展經貿活動服務，促進中國同世界各國的經濟聯合和貿易往來，為中國社會主義現代化建設服務。

二、本《指南》所刊登的文章、資料系由中國經貿、金融、理論等各界專家、學者所撰寫和提供，內容廣泛全面，完整系統，資料翔實，數據準確，是建國以來中國對外經濟貿易領域僅有的一部集各國經貿指南和企業名錄為一體的大型工具書，也是中外各界經貿人士用以開展貿易、投資和經濟合作的必備書籍。

三、本《指南》各卷根據地區、國別不同，分別介紹各國（地區）貿易情況及主要進出口企業，本分冊為《中國卷·大陸分冊》1993（不含港、澳、臺）。

四、本分冊由“貿易指南”和“工商企業名錄”兩部分組成。其中，貿易指南部分分十個章節：經濟概況、外貿管理與法規、投資政策、外匯管制、銀行業務、保險業務、中國沿海開放地帶、主要經濟管理機構、主要商會及協會、主要商業銀行。

五、本分冊“貿易指南”部分皆采用英、中文對照形式，英文左頁，中文右頁，為照顧海外讀者習慣，中文為繁體漢字。

六、行業及產品分類說明：

1、本分冊“工商企業名錄”部分根據中國進出口企業行業分布的基本情況，以聯合國標準產業分類ISIC（第三稿）第一、二級部類合并劃分而成，共分十五章節。

2、由于各國產品分類體系不同，本分冊在參考中華人民共和國國家標準GB4754—84《國民經濟行業分類和代碼》，根據聯合國標準產品分類體系，在章節內按產品名稱的英文字母排列順序進行分類。

3、產品分類下具體介紹中國大陸主要進出口企業，包括名稱、地址、電話、電傳、傳真和經營範圍，各公司企業一律以其名稱的英文字母排列順序編排。

4、本分冊共收錄4000家左右的公司企業，皆以其主要產品為主，原則上刊載一次。

七、“工商企業名錄”翻譯說明：

1、本分冊“工商企業名錄”翻譯工作皆聘請專業英語人員擔任。每條名錄均翻譯企業名稱和經營範圍兩項，內容皆采用英文、中文混排格式，英文在上，中文在下。其中地址、電話、電傳、傳真部分考

慮到國際通用原則，保留原樣不譯。

2、凡企業名稱中出現的地名皆參考《世界地名譯名手冊》，并根據漢字譯寫通則中的規定進行翻譯。

3、企業名稱的翻譯一律按照原有中文名稱，按漢語普通話音譯標準翻譯。

八、索引：

本卷共設英、中文索引六項：名錄索引（英文、中文），產品分類索引（英文、中文），廣告索引（英文、中文）。為方便讀者，考慮到現代科學的要求，本卷索引編纂一律依常規電腦程序處理。英文索引一律按英文字母順序編排；中文索引按普通話漢語拼音順序編排。

After the publication of *The Directory of World's Industrial & Commercial Organizations / Southeast Asia*, we have compiled *The Directory of World's Industrial & Commercial Organizations / China (Hong Kong & Macao) and China (China • Mainland)*. Meanwhile, we are stepping up the compilation of *China (Taiwan Province)* for publishing it at the earliest time possible so that it can better serve China's economic situation of reforms and opening-up. The volume of *China* is an important component part of the multi-volume reference book of *The Directory of World's Industrial & Commercial Organizations*. It is so not only because China is the motherland of all the members on the editorial board, but also because an opening China has an urgent need to understand the world and the world is even more anxious to learn about China. EXPLANATORY NOTES

A. With approval by the News and Publication Administration of the People's Republic of China, *The Directory of World's Industrial & Commercial Organizations* was listed in December 1990 into the publication plan of the Economic Management Publishing House for the Eighth Five - Year Plan period. This book is the *Directory's* second volume, the volume of *China (China • Mainland 1993)*, to be published together in English and Chinese. The *Directory* is a creative and instructive reference book combining guide to trading and directory of companies. With its comparatively complete and systematic introduction of the economic and trade policies, customs laws and regulations, investment policies, foreign exchange control, banking, insurance, names of industrial and commercial organizations of each region and country as well as other relevant contents necessary for conducting economic and trade activities, the *Directory* is designed to provide direct services to the economic and trade activities carried out by people of various domestic and overseas circles engaged in economic relations and trade, industry, commerce, finance, and other fields; to promote the economic cooperation and trade exchanges between China and various foreign countries; and to serve the construction of China's socialist modernization.

B. The articles and data contained in this *Directory* are written and provided by Chinese experts and scholars devoted to the study of economic relations and trade and finance and relevant theories. With its extensive, complete and systematic contents, reliable data, and accurate statistics, the *Directory* is a large reference book and the only one of its kind published in the field of foreign economic relations and trade since the founding of the People's Republic of China to combine the economic and trade directories and enterprise names of various countries. It is also a must for people from various domestic and overseas circles to conduct trade, investment, economic cooperation, and other relevant activities.

C. Each volume of the *Directory* gives, according to different regions and countries, a specific introduction to the trade and major import and export enterprises of these regions and countries. The volume of *China (China • Mainland 1993)* does not cover such areas as Hong Kong, Macao, and Taiwan Province.

D. This volume is composed of two sections: "Guide to Trading" and "Directory of Companies". The first part is divided into ten chapters: economic situation, trade control and regulations, investment policy, exchange control, banking services, insurance, China's Coastal Open Areas, major economic management organizations, major chambers of commerce & associations, and major commercial banks.

E. The "Guide to Trading" section is written in English with Chinese translation, with the former printed on the left page and the latter on the right page. In order to cater to the habits of overseas readers, the original complicated forms of the Chinese characters are used.

F. Explanations to classification of trades and products:

a. The "Directory of Companies" in this volume is classified by making reference to the basic conditions of the layout of the major import and export business in China and combining the first and second categories of International Standard Industry Classification (ISIC) (3rd edition). They are divided into 15 chapters.

b. Because of the difference in the classification of products in different countries, this volume made reference to *China GB 4654—84 Industrial Classification and Codes for National Economic Activities* and UN systems of standards on products classification, making classifications according to the alphabetical order of the English names of products in each chapter.

c. Under the items of product classification, detailed introductions are made of the major import and export enterprises of China's mainland, including their names, addresses, telephone and telex numbers, telefax numbers, and business scopes. All companies and enterprises are arranged according to the alphabetical orders of their English names.

d. This volume has a collection of about 4,000 companies and enterprises, with emphasis put on their major products. Each company or enterprise occurs only once in principle.

G. Explanations to the translation of "Directory of Companies":

a. The translation of the "Directory of Companies" of this volume is trusted to people specialized in the English language. Of each entry, the name of the organization and its products/ services are translated into English. The contents are written in both English and Chinese, with English above and Chinese below. As for the address, telephone and telex numbers, and the
