- 1. This book is an encyclopedia introducing general situation and investment environment in Shenzhen Special Economic Zone (including Baoan County). 序言

八年前,經中華人民共和國全國人民代表大會批准,深圳經濟特區正 式成立。

建立經濟特區是中國政府的一項創舉,是我國實行對外開放政策的一個重要組成部份。深圳經濟特區不僅是中國對外開放的重要門戶之一,而且又是我國率先對外開放、率先改革的一塊試驗地。八年來,我們逐步確立了獨特的發展戰略——建成一個以工業為主,兼營商業、房地產、旅遊、農牧業的外向型的綜合性經濟特區,充分發揮技術、知識、管理、對外開放政策的四個"窗口"和對內對外兩個"扇面"輻射樞紐的作用。為達到這個目的,我們遵循"特區的改革要跳出現行體制之外"的原則,深入地、大胆地進行了各方面的改革,初步建立起以市場調節為主的市場體系,推動了全市的外引內聯工作。到目前為止,全市建成1400多家外資企業、近3000多家內聯企業,外資企業、內聯企業和市屬企業構成了深圳市經濟發展的三大組成部份,有力地促進了深圳經濟的全面發展,使昔日的一個邊陲小鎮發展成初具規模的、以工業為主的、經濟結構較為合理的、多功能的現代化城市。

經過八年的奮鬥,深圳已爲國內外投資者創造了一個較好的投資環境,無論是在基礎設施、水電供應等硬件上,還是在辦事程序、辦事效率、法律保障等軟件上都有較大的改善,初步創造了投資者能按國際慣例

生產經營的環境和條件。事實証明,絕大多數的外資及內聯企業在深圳生產經營情況良好、效益理想、資金回收快、投資合作雙方較滿意。

Preface

---- by Mayor of Shenzhen Lihao

Shenzhen Special Economic Zone was formally founded by approval of National Congress of the People's Republic of China eight years ago.

The founding of Special Economic Zone is a creation of our government, and is an important composing part for our country to carry out open policy to the world. Shenzhen SEZ is not only one of the important doors for China to open to the world, but also an experimental area for our country to open to the world and reform firstly. We have established a set of special developing strategy during eight years - setting up an open type's comprehensive SEZ which takes industry as the lead and operates Commerce, Estate, Travelling, Agriculture and Stock Raising as well, fully displaying the role of "four windows" of technology, knowledge, management and open policy to the world and the radiating and key role of "two sectors" of facing to inland China and the world. For reaching this purpose, we observe the principle that "Reformation in SEZ should jump out of the present system" and carry out reformation deeply and boldly in all circles. We have intially set up a market system mainly according to the principle of market adjustment and promoted the work at foreign investment introduction and domestic co-operation in whole city. So far we have established 1,400 enterprises with foreign investment and 2,600 enterprises with domestic co-operation in whole city. Enterprises with foreign investment, enterprises with domestic cooperation and enterprises under Shenzhen Municipal Government compose the three basic compositions of Shenzhen economic development. They promote Shenzhen economic development forcefully in all circles and make the little town on border develop to be a morden city with industry as the lead, reasonable economic structure and multiple-function.

Shenzhen has set up a better investment environment by endeavour of eight years. Both the hardware in fundamental construction and water and power supply etc. and the software in business procedures, business efficiency and legislation etc. have improved greatly. The environment and conditions in which investors can produce and operate according to international convention have initially established. It is proved by the fact that most of the enterprises with foreign investment and enterprises with domestic co-operation have been running very well. They get expected benifits and their fund returns fast. Both parties of investment and co-operation are very satisfactory.

According to the strategical decision of Central Committee and State Council Shenzhen should further play the role of experimental area and the lead soldier in reformation and openning in order to promote openning in coast area and inland China in steps, to realize the strategy that "Both ends are out of China" and "import and export greatly", and to take part in international economic circulation. Recently the Central Committee and State Council offer some preferential policies of carrying out plan independently etc. to Shenzhen, which will make the steps of

reformation and openning in Shenzhen to stride more greatly and fast. We believe that Shenzhen will be more attractive to foreign and domestic investors because of its good geographic position next to Hongkong, initially completed investment environment, experiences of reformation and openning in eight years, reasonable industrial structure and strong economic power, and more preferiential policies offered by state.

"Shenzhen Investment Guide" edited by Planning Office under Shenzhen Municipal Government introduces the fundamental situation, developing programming, investment environment, circles welcoming to investment, investment guide in county and districts, investment protection, government structure and catalog of enterprises etc. in detail. It is the first complete encyclopedia on investment in Shenzhen. We hope that the publishing of "Shenzhen Investment Guide" will convenience foreign and domestic enterprisers, make them to know much more about Shenzhen and act as a guider and bridge for investors coming to Shenzhen. We sincerely welcome people to visit Shenzhen and invest in Shenzhen. We especially encourage to run the advanced industrial projects in technology-orient and knowledge-orient and the industrial projects which are needed in China and can make foreign exchange facing to international market. We shall continue to offer preferiential treatment and provide warm services.






