## Preface

随着经济全球化进程的加快,我国与世界各国的商务活动以及在经贸领域的合作日益频繁,商务英语的学习也因此受到越来越多学习者的重视。对于那些有志于从事商贸活动的职场人士以及在校大学生而言,通过 BEC 考试、获得剑桥商务英语证书即是成功迈向商贸领域的第一步。

有鉴于此,星火英语特为上述群体和广大英语学习者精心推出了"BEC 剑桥商务英语考试辅导系列"丛书,其中包括"高频词汇精讲"、"主题词汇随身记"、"新思维高分快训专项"和"BEC 高分快训系列"四大系列 15 本图书。

在此基础上,星火英语再接再厉,又推出了《新思维 BEC 听力高分快训(高级)》一书,以满足较高水平的考生和学习者的需要。该书共包含三章:第一章"知己知彼",是对 BEC 高级听力考试的综述,分题型介绍 BEC 高级听力的题型特点、命题规律、解题要点及技巧;第二章"全面武装"包含 BEC 高级听力仿真试题及解析:针对 BEC 高级听力的三个题型,根据 BEC 高级听力考试的命题规律及出题特点,分别提供高度仿真模拟题,并针对不同题型给出不同方式的解析和相关练习;第三章"实战演练",包含 BEC 高级听力综合测试,我们依照 BEC 高级听力考试的命题规律及出题特点,设计了四套仿真听力综合模拟测试题,并提供答案、听力原文和解析,以方便广大考生和读者自测和检验。

本书核心内容是第二章的分题型模拟训练与解析,其中 PART ONE 采用听力原文与中文解析 左右对照的形式,指出原文中的解题关键点、答案提示信息以及干扰信息,总结解题规律和方法; PART TWO 采用分段解析的方式,以图解的形式将每段录音的关键内容及答案推导思路呈现出来,并简明扼要地点出了做题的不同策略及干扰项的排除依据; PART THREE 则应用流程图和文字解析相结合的方式,提炼每道题对应的听力原文的思路、脉络,进而显示答案的推导过程。



# Chapter 1

第一章 知己知彼

第一节 填空题

#### 一、题型介绍

该部分试题属填充空白题,录音是一篇独白。命题者将其分为若干部分,每部分留有几个空白处。 全文共有 12 处空白,较为均衡地分布在试题之中,以便考生有充裕的时间填写答案。要求考生根据所 听内容在空白处填写关键词,每个空白处所填写的关键词不超过三个。试题录音长度大约 2~3 分钟。 录音播放两遍。

#### 二、命题规律

试题内容多为信息性的材料,侧重于可以辨认的事实或数字。其主题涉及范围较广,如演讲、情况介绍、产品说明;发布消息、下达指示;更改计划、调整安排;协商会议议程、组织事件的细节等。题目的语境可能是打电话,可能是会场,也可能是课堂,不一而足。

#### 三、解题要点

考生应在正文录音播放之前,充分利用所给的时间,迅速浏览一遍整个题目和相关的文字,对要听的内容有一个大致的了解。听录音时要关注空白前后的文字,看能否判断出空白处应填写的词的词性或是哪个方面的内容。注意录音中的重读、连读和弱读现象。因题目的顺序与该信息出现在录音中的顺序相同,所以考生要边听边记,跟上录音的节奏。如果某个空白处的内容在听第一遍时没有抓住,不要再多加考虑,而要随着录音的节奏马上转入下面的内容,待听第二遍时将其补上。另需注意的是,空白前后的文字并非采用录音中相关句子的语序或词序,多数情况下都做了调整,或者用另一种说法加以转述。因此,真正听懂录音内容才是做题的关键。

## 第二节 配伍题

#### 一、题型介绍

该部分试题为多项配伍型试题,即内容与主题和具体细节的搭配。听力材料是五篇摘录,即五个人的独白。每个人的独白均围绕一个共同的主题或论题。五篇摘录播放两遍,每遍大约3~4分钟。每篇摘录有两个问题,分别列在两个部分的选项中;它们与摘录的内容和主题等相关。要求考生根据所听内容,从给出的两组选项(各含八个)中做出选择,即八选五,其余三项是干扰项。

#### 二、命题规律

该部分试题有共同的主题或论题,涉及范围亦十分广泛。所谈主题或论题均与商务活动相关,但并不涉及专业性很强的内容,因此考生只要具备一般的常识即可应对。独白的篇幅适中,每篇字数约 100 ~120 左右。要求考生回答的问题大致有以下几个方面:判断讲话者的身份、解释独白的语境、了解所说话语的功能、辨别所讲的主题、捕捉具体的信息、确定说话者的意图或态度等。

#### 三、解题要点

考生亦应在正文录音播放之前,充分利用所给的时间,迅速浏览一遍整个题目和相关的文字,对要听的内容有个大致的了解。由于该部分的试题分列在两个部分,第一部分选项与独白的主题有关,第二部分选项与独白的内容细节有关,所以考生可以选择在听第一遍录音时做第一部分的试题,在听第二遍录音时做第二部分的试题;也可以同时做两部分的试题。不过笔者认为,同时关注两组选项中的试题容易分心,效果不佳,建议考生采取第一种做题方法;同时,要注意排除干扰项,可采用排除法、推断法等,先排除比较明显的错误选项,再根据内容逐个排除,最后确定正确答案。
