主编的话

《精神障碍治疗学》第4版问世距最初编写本书的构想已过去了四分之一世纪。Daniel X. Freedman 医学博士在其担任美国精神病学学会(American Psychiatric Association, APA)主席期间,于1982年指定成立了《精神障碍治疗学》工作组,其任务是编写一部较为全面的精神障碍最佳治疗方法目前观点的论著。工作组将主要精神障碍的治疗专家们分为数个小组,参阅尽可能多的治疗学文献,同时向组外顾问广泛征求意见以达成共识。

在经过了广泛的文献综述之后,第1版《精神障碍治疗学》作为 APA 工作组的报告于 1989 年出版,这部论著共有四册,其涉及领域相当广泛,很快就成为了美国精神科治疗学的首席参考书。继 Karasu 医学博士之后,我应邀成为了《精神障碍治疗学》第2版的主编。我们将卷数缩减了一半,于 1995 年和 2001 年分别出版了第2版和第3版,均为两册。为了进一步精简,我们要求编写内容仅限于治疗领域,读者可以通过阅读其他教科书以了解诊断问题。

在第4版的编写过程中,我与美国精神病学出版社的主编 Robert E. Hales 医学博士、编辑部主任 John McDuffie 广泛交流了意见。为了提高该书实用性,我们作出了一个重要的决定,将第4版缩减为一册,删掉了治疗概论的有关章节,使得读者可以直接看到各种精神障碍的针对性治疗。

在精神障碍治疗领域的知识迅速增长的情况下, 对《精 神障碍治疗学》一书作进一步精简就需要熟练的编辑和广博 的知识以决定哪些内容可以删减。为此我召集了一批优秀的 章节负责作者,他们都是各个精神障碍研究领域内的著名专 家,包括: Elizabeth B. Weller 医学博士和 John F. McDermott Jr. 医学博士负责编写婴幼儿期、儿童期及少年期精神障 碍, Stuart C. Yudofsky 医学博士和 Robert E. Hales 医学博士 负责编写谵妄、痴呆、遗忘障碍及其他认知障碍,Herbert D. Kleber 博士和 Marc Galanter 医学博士负责编写物质相关障 碍, Richard L. Munich 医学博士和 Carol A. Tamminga 医学博 士负责编写精神分裂症和其他精神病性障碍, A. John Rush 医学博士负责编写心境障碍, Franklin R. Schneier 医学博士、 Lisa A. Mellman 医学博士和 David Spiegel 医学博士负责焦虑 障碍、分离性障碍和适应障碍, Katharine A. Phillips 医学博 士负责编写躯体形式障碍及做作性障碍, Stephen B. Levine 医学博士和 R. Taylor Segraves 医学博士负责编写性及性身份 障碍, Allan S. Kaplan 医学博士和 Katherine A. Halmi 医学博 士负责编写进食障碍, John G. Gunderson 医学博士负责编写 人格障碍。由于睡眠障碍和冲动控制障碍章节内容很少,就 没有指定章节负责作者。

我们与各章节负责作者们一起竭力整合读者最需要的治疗信息而尽量不删减基本信息,这本书仍能为临床医生提供其所需了解的精神科治疗艺术。我们再次允许"读者友好"的编辑风格,有的部分每一主要治疗方式各占一节,而有的部分是按照疾病来组织章节。

在编写过程中,作者们不断更新自 2001 年第 3 版出版以来的参考资料直至本书付诸出版,这就尽可能使本书的内容是最新的观点。我们要求作者们删掉那些不再需要的旧信息以减少篇幅,还对每个章节进行了严格的字数限制。我们继续保持重点来源于对各种主要精神障碍随机对照试验的循证治疗的传统。同时,我们也清楚对照试验的数据并不总是普遍适用于临床自然背景,我们鼓励作者在某个领域的试验研究太少时可以从非对照研究中总结数据和列举临床治疗经验。我们认识到医生的临床判断总是被运用于制定对患病个体的最终治疗决策。

我们编写的这本治疗纲要并不代表美国精神病学学会或 其他团体关于精神障碍治疗方法选择的正式观点,它仅是专 家意见和临床经验的汇编,可以帮助临床医生制定合理的个 体化治疗方案。由于精神障碍的共病现象较为普遍,本书中 的治疗信息可以被灵活运用于那些共病患者。

就在本书付印前,传来了我们的一名作者——Wayne Fenton 医学博士去世的噩耗。Wayne Fenton 医学博士是一位敬业的研究者和医生,他为人们更好地了解精神分裂症作出了重要的贡献。我们都很怀念他,也很荣幸本书收录了其最后作品之一。

最后,我要对整个工作组致以诚挚的感激,章节负责作者们进行了大量的工作,按照编写提纲付出了辛勤努力。 Tina Coltri-Marshall 的协调工作做得很好,在进度落后的时候及时通知各位章节作者;Robert Hales 和 John McDuffie 同时担当着顾问和支持系统的工作;Diane Trees-Clay 是一位很能干的助手,协助我完成了这项艰巨的任务。我还要向美国精神病学出版社的编辑团队表示感谢:Rebecca Richters 和Greg Kuny负责编辑和出版工作,Jennifer Molnar 负责封面和版面设计,Judy Castagna 负责印刷事务。他们的工作很出色,很荣幸能与他们一起共事。
