## Foreword for Students and Teachers

Congratulations on your decision to pursue excellence on the TOEIC exam. The Test of English for International Communication is used world-wide as a measurement of English language ability by businesses, schools, and government organizations. While the exam is taken by thousands of students each year, you have decided to set yourself apart by training yourself to face the specific challenges that you will meet on exam day.

Of course, your score on the exam will be determined in large part by your English knowledge and ability. However, familiarity with the exam itself can provide test-takers with an added advantage. The practice tests included in this book are designed to provide you with that familiarity.

### How to use the materials in this book

In order to get the greatest benefit from the practice exams in this book, examinees should first prepare as completely as possible BEFORE taking the exams. The best way to do so is to complete the three books in the Target New TOEIC series

- Listening
- Grammar and Vocabulary
- Reading

These three volumes will provide you with knowledge and help you develop the skills you need to perform well on the exam.

Next, you should treat each practice exam as if it were a real exam. For instance, if you have read the books listed above, you already understand the importance of being able to read and answer the listening comprehension questions as the conversations are ongoing. You already understand that it is imperative to analyze the grammar and vocabulary questions as efficiently as possible in order to have as much time as possible available to you to complete the reading questions. You already understand that some reading questions

allow you to collect points quickly while others will require you to invest more time. However, understanding these issues is not sufficient preparation; examinees need to actually practice employing the strategies they have learned about. These exams provide you with that opportunity by allowing you to mimic actual testing conditions.

On the listening sections, simply follow along with the sound files on the CD. Do NOT pause the CD while you search for answers; doing so will give you an advantage that you will NOT have on the day of the actual exam. Needless to say, you should not replay the conversations while you are taking the practice tests because you will not be able to do so on the day of the real exam.

For parts 5, 6, and 7, you should prepare a clock or stopwatch before you begin. You should be strict about the time limit. The exam is not testing whether you have the ability to answer the questions. The exam is testing whether you can do so within a specific period of time. Giving yourself an unlimited amount of time will result in a higher score than you can possibly achieve on the day of the strictly-timed real exam.

If you are working with a teacher, your teacher should be able to use your performance on these practice exams to identify areas that are particularly troublesome for you. For example, an experienced teacher will be able to notice that, say, most of your wrong answers on Part 2 were on “Positive/Negative” questions. Perhaps your problems on the grammar section were mostly related to verbs. Using these practice tests under the guidance of an experienced teacher can make them even more effective than using them alone.

Whatever you choose, the exams in this book will bring you the confidence that you need prior to walking into the test center. Your confidence and experience will enable you to perform better than other, less prepared examinees with a similar level of English ability.

## 前言：给学生和老师们

恭喜你决定要在托业测验上追求更上一层楼的表现。托业(The Test of English for International Communication, TOEIC)被全世界的工商界、学校和政府单位用来当作衡量英语能力的指标，每年都有成千上万的人应考，而你也已下定决心要好好训练自己，以便在考试当天面对特定的挑战。

当然，你的成绩大部分取决于你所具备的英语知识及能力，但是，熟悉托业测验内容能够让你多一项附加优势。本书的全真模拟测验就是用来让你熟练测验内容的。

### 如何使用本书

为了让书中的模拟测验发挥最大的功效，考生在测验之前应该先尽可能做好准备。而要达到这个目标最好的方法就是一并研读以下《瞄准新托业》(*Target New TOEIC*)的其他三本书：

- 《瞄准新托业(听力篇)》
- 《瞄准新托业(词汇·语法篇)》
- 《瞄准新托业(阅读篇)》

这三本书能够提供你一些有用的知识，有助于培养你取得好成绩所需要的技巧。

接下来，你得把本书的每套模拟测验都当作是真正的测验。假如你已经读过上述的前三本书，就会了解到有能力在听力测验对话进行的同时阅读并作答的重要性，也会认识到有足够的时间完成作答，必须有效

地分析语法和词汇问题，更会了解到有些阅读题目能很快得分，但有些就需要花点时间来作答。但是，了解这些还不够，你需要实际的练习来将所学的内容加以运用，而本书的模拟测验提供了这样的机会。

在 Part 1~Part 4 的听力单元，你要跟随音频文件的节奏作答，不可任意按下暂停键，从而增加在考试当天无法暂停音频文件的优势。至于在模拟考途中回放对话内容就更不用提了，你根本不该这么做，因为在真正考试当天，是不可能重听一次的。


针对 Part 5、Part 6 和 Part 7 的阅读测验，在进行前应该先准备好一个时钟或秒表，严格限制自己的作答时间。托业测验考的不是你有没有能力回答问题，而是你能否在限定的时间内作答完毕。若你在进行模拟测验时不设定时间，仿真出来的分数当然会比考试当天在有限的作答时间下所得到的分数要高得多。

假如你在准备测验的过程中有老师陪着你，老师应该能够根据你在模拟测验中的表现分析你不足的地方。举例来说，一个有经验的老师要能够注意到，当你在 Part 2 中出错的大多是“Positive/Negative”问题时，你在语法上的问题可能大部分与动词有关。比起单单靠自己埋头苦练，在一位有经验的老师带领之下，这些模拟考试将能够发挥更大的效果。
