## 序

邓婷婷博士的大作《国际投资协定中的公平与公正待遇研究》即将面世之际,希望我说几句话,不亦乐乎。投资的国际经贸合作久已有之,当代此类合作的特点是双边投资协定及区域和多边自由贸易协定,投资章节均包括实体内容相同、具体文字表述微异的涉及外国投资者与投资的相对和绝对待遇。公平与公正待遇为绝对待遇标准之一。鉴于国际投资协定仅规定东道国有义务向外国投资者和投资提供“公平与公正”待遇,而无具体规定何为“公平”,何为“公正”,使得负责争议解决的仲裁庭可较大限度地行使裁量权。这也使得投资仲裁庭更似国际投资领域的准司法审查机构。

国际投资的另一特点是判例法的成型。理论上,任何仲裁庭的裁决均无具拘束力的先例之作用,然而实践中无论是争议当事方还是仲裁庭均无例外地援引先前的裁决。有的仲裁庭声称如此做法是为了维护国际法的一致性,有的则认为先前的裁决应具说服力的效力。

基于前述,对国际投资的公平与公正待遇之研究如不侧重实践中仲裁庭对之进行的解释则无法得窥全豹。

本书以东道国监管权与外国投资者应享有的利益为视角,通过对投资仲裁庭的裁决梳理总结,对公平与公正待遇的溯源、性质、内涵等进行了全面系统的研究。总体而言,此书视角新颖,反映了当前公平公正待遇的理论与实践,体现了作者扎实的理论功底与把握学术前沿问题的能力,促进了国际投资法的研究,是一部难得的学术专著。

作为邓婷婷的硕士及博士生导师,我为此书的出版感到高兴与欣慰。付梓在即,特致数语,是为序。
