Introduction

At present, there is no universally and commonly acknowledged international standard for discipline cultivation of Chinese medicine medical research in institutions, universities and colleges all over the world. To establish a unified discipline classification system of Chinese medicine, and promote the standardization and applicability of discipline classification of Chinese medicine, this standard is established, providing basis for global course system construction, personnel training and scientific research of Chinese medicine.

This standard is based on *The Key Discipline Committee of Experts' Discipline Construction Planning Guidance Catalogue of Chinese Medicine* by State Administration of TCM of People's Republic of China, and at the same time refers to relevant laws and regulations in other countries.

The International Catalogue of Chinese Medicine Discipline System may guide the construction of Chinese medicine disciplines, improve the talents cultivation, ensure systematicness and integrity of Chinese medicine disciplines, and promote the perfection of Chinese medicine.

International Catalogue of Chinese Medicine Discipline System

1 Scope

The standard specifies the basic terms of the discipline system of Chinese medicine.

The standard applied the discipline construction and cultivation of talents of Chinese medicine .
