## **Chapter 1** Exploring Mechanisms for a New Think Tank

Weiguang Wang graduated from Peking University in 1982. Later, he was admitted to the Department of Theory of Party School of the CPC and got his master and doctoral degrees of philosophy. He served as Member of the 10<sup>th</sup> National People's Congress and Member of Law Committee of National People's Congress. Currently he serves as President and Secretary of Party Committee of Chinese Academy of Social Sciences, President of Presidium of Academic Divisions, Professor and Doctoral Supervisor, Member of the 18th Central Committee of CPC, President of Chinese Association of Dialectic Materialism Study, Member and Chief Expert of Advisory Committee of Marxist Theoretical Study and Building Engineering. He once served as Vice President of Party School of the CPC Central Committee and Member of the 16<sup>th</sup> and 17<sup>th</sup> National Party Congress of CPC. In 1987, he got the honorary title "National Doctorate Recipients with Outstanding Contributions" issued by the State Council. He enjoys special government allowances of the State Council.

He mainly studies Marxist philosophy and Marxism basic theory, Marxist Chinesization and theoretical innovation of the Party, and major theory and practice of socialism. He published more than 30 academic monographs, mainly including: Theory of Social Contradiction, Theory of Interest, Basic Issues of Scientific Development Concept, Basic Issues of Theory of Socialist Harmonious Society and Chinese Road and Marxist Chinesization. Main works published under his general editorship include Basic Issues of Marxism, Introduction to Important Thought of "Three-representative", Study of Important Thought of "Three-representative", Introduction to Scientific Development Concept, Theory and Practice of Building New Socialist Countryside, and History of Socialism (Eight Volumes). He haspublished more than 400 papers in national-level newspapers and magazines.

Baige Zhao currently serves as the Member of National People's Congress (NPC) Standing Committee, the Vice Chair of Foreign Affairs Committee of National People's Congress, the Vice Leader of CASS-RDI Leading Group and Chair of the Advisory Committee, the Vice President of International Federation of Red Cross and Red Crescent Societies (IFRC) and the Member of National Committee of Experts on Climate Change.

Dr. Baige Zhao obtained her Ph. D. from University of Cambridge. From 1989 to 1994, Dr. Zhao served as the President of Shanghai Institute of Planned Parenthood Research, Director General of Cooperation Centre of WHO and member of Committee of Experts in Asia Pacific region of WHO. During this period, she completed a series of research and development work on new medicines.

From 1994 to 1998, Dr. Zhao served as the Director General at the Life Science and Technology Development Center (USA), affiliated to State Scientific and Technological Commission. She accomplished the establishment of the Overseas Experts Committee, the work of international promotion, financing and registration of national core projects on modernization of traditional Chinese medicine. She also succeeded in the internationalization of a group of traditional Chinese medicines such as the Danshen Dripping Pills, and helped entre the international market and become listed a number of Chinese pharmaceutical enterprises such as Tasly Holding Group and LuyePharma.

From 1998 to 2011, Dr. Zhao served as the Vice Minister of National Population and Family Planning Commission (NPFPC). During her post in NPFPC, she enhanced the formulation of national population development strategy, the execution of the reform in the population area, the perfection of the service of high quality and the adjustment of family planning policy. She advocated the incorporation of scientific research, technology and Industry, the intensification of South-South cooperation and South-North dialogue and achieved the support from international community to the Chinese population development programs. During her participation at the UN Climate Change Conference in Copenhagen, she proposed the integration of demographic issue into the comprehensive plan of settlement of climate change issues. She served also as Chair of the International Population Program Management Committee and Vice President of Asia Pacific region of the World Family Alliance.

From 2011 to 2014, Dr. Zhao served as the Executive Vice president of Red Cross Society of China and was elected as the Vice President of International Federation of Red Cross and Red Crescent Societies. She was in charge of the affairs in the Asia Pacific Region including the Middle East and Pacific islands region, etc. with the active promoted of the settlement of international humanitarian crisis, the effective management of conflicts and disasters and the successful organization of the humanitarian relief operations in response to the Philippines Yolanda typhoon, Northern Myanmar refugees and Sichuan Ya'an earthquake, etc.

Since 2013, Dr. Zhao has been Vice Chair of Foreign Affairs Committee of National People's Congress(NPC), member of Standing Committee of NPC, the Chair of Sino-British Parliamentary Exchange Mechanism, the Executive President of Sino-South African Parliamentary Exchange Mechanism, Bilateral Friendly Group Chairs of National People's Congress with 8 European countries such as UK, and with 13 African countries. She dedicates the efforts in the exchanges of NPC with foreign parliaments and MPs concerned, and intensifies its influence at Asian Parliamentary Assembly and on other multilateral platforms.

In 2015, she was nominated as Vice Leader of CASS-RDI Leading Group and Chair of the Advisory Committee. She organized research of the major projects of CASS-RDI in 2015, launched the implementation phase of China-Pakistan Economic Corridor and China-Iran Economic Corridor of the "OBOR", organized the service team to develop the Going Global Strategy of Chinese enterprises and contributed to the construction of the "OBOR Initiative".

He graduated from the Department of Agricultural Economics of Renmin University of China in 1982 and got his bachelor's degree in economics. He graduated from the Graduate School of Chinese Academy of Social Sciences in 1985 and got his master's degree in economics and got his doctoral degree in economics in 1989. Since 1985, he served as Research Assistant and Associate Research Fellow of the Rural Development Institute of Chinese Academy of Social Sciences and the Director of the Research Office. He became a Research Fellow in 1993 and then served as Deputy Director of the Population Research Institute of Chinese Academy of Social Sciences and the Director of the Demography Department of Graduate School of Chinese Academy of Social Sciences. He served as Director of the Population and Labor Economics Institute of Chinese Academy of Social Sciences, Doctoral Supervisor and the Editor-in-Chief of the magazine *Population Science of China* since 1998.

Since March 2008, he has served as the Member of Standing Committee of National People's Congress, Member of Agriculture and Rural Affairs Committee, Vice Chairman of the China Population Association and Chinese Association of Agricultural Economics, Member of the Soft Science Committee of the Ministry of Agriculture and Member of the Expert Committee of Ministry of Labor and Social Security. He has served as Vice-President of Chinese Academy of Social Sciences and the Member of the Party Group since August 2014.

His works include China's Dual Economic and Labor Transfer—Theoretical Analysis and Policy Recommendations, Choices at the Crossroads—Thinking of Deepening Reform of Agricultural Economic System, The Economics of Being Poor and Development and Transformation of Chinese Labor Market.
