# ABSTRACT

---

National economic security holds a very important strategy position in its economy development and it is also a major issue concerned by all the nations. Nowadays, it becomes an important research field of international issues and a new point under the background of the economic globalization and integration, especially financial globalization.

With the rapid development of financial globalization, the concept, major contents and influential factors of national economic security changes significantly. Financial security becomes the core of national economic security. Accordingly, financial crisis also becomes a major threat to national economic security. In particular, the international contagion of financial crisis in recent years becomes more common, which makes the effects to the economic security of the home country from the financial crisis of other countries more significant. Therefore, from the view of the global large-scale economic system, the research on national economic security from the point of view of international contagion of financial crisis has important theoretical and practical significance.



This book firstly makes a literature review of the research works on the national economic security and international financial crisis. There are huge amount of researches on these two topics and many researchers did thorough work. However, the research that combined the two aspects organically is less. At the same time, based on the re-understanding of the concept, major contents, features and influential factors of national economic security under the background of financial globalization, this book concludes that international financial fluctuation has more and more significant effects on the national economic security. Therefore, this book sets up a new research thought to analyze national economic security from the point of view of international financial crisis.

To analyze the influential mechanism of international financial crisis to the national economic security, we should firstly have a deep understanding about the international financial crisis contagion. This book analyzes the effects of financial globalization on the propagation mechanism of international finance and introduces the concepts about international financial crisis contagion. According to the previous methods which were disadvantaged to test contagion effects of financial crisis, this book applies the Granger Causality test of VAR model and impulse response to verify the existence of the contagion effect of the international financial crisis. The result shows that it is very necessary and important to study on the influential mechanism of international financial crisis to national economic security.

This book builds a Global Large-Scale Economic System with N national Real Sectors and Financial Market, a set of K banks for the global economy and M non-bank financial market participants. Within this system, this book analyzes the contagion channels and mechanism as well as the effects to a nation's economic security from international financial crisis. Our main work is as follows:

The real contagion mainly affects a nation's trade security and industry security by competitiveness effect, income effect, cheap-import effect, competitive devaluations effect and industry linkage effect. The financial contagion mainly affects financial security and fiscal security by the common creditor effect, indirect creditor effect, portfolio diversification effect and liquidity shocks effects, and expectation contagion does by the herd effect and demonstration effect. On these bases, with an example of Asian financial crisis, this book comprehensively analyzes the effects of international financial crisis on the whole national economic security.

Finally, this book analyzes the invisible contagion effects of international financial crisis on the national economic security of China before entering WTO, the possible contagion channels and contagion mechanism of international financial fluctuation in China opened increasingly after entering WTO, as well as the policy implication of financial crisis international contagion effect to Chinese government maintaining national economic security.
