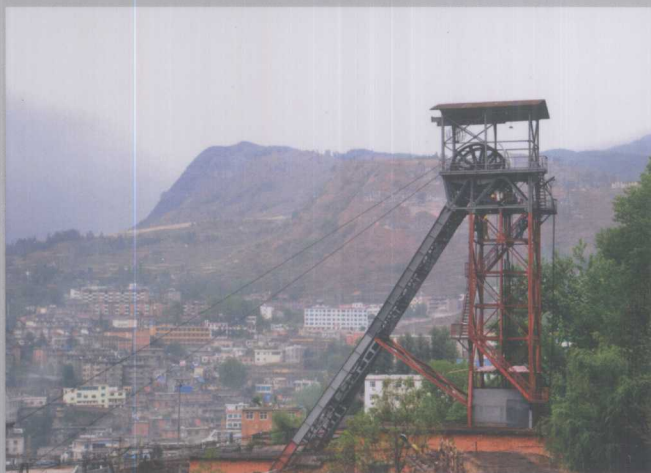

贵州盘江投资控股（集团）有限公司是省属大型国有企业，经历了盘江矿务局、盘江煤电（集团）有限公司的体制沿革。2010年2月经贵州省国资委批准业务转型并更名，入驻贵阳市。

近年来，坚持“以煤为主、多业并举、科学发展”的思路，加速发展、加快转型，企业规模持续增长，经济实力不断增强。2007年原煤生产超千万吨，居江南煤炭企业第一。2009年4月实现了煤炭主业整体上市。2010年，资产总额达147亿元，净资产达81亿元，生产原煤1280万吨，营业收入90亿元，名列全国煤炭企业100强第49位。

In February 2010, Guizhou Province SASAC approved the business transformation and renamed, settled in Guiyang.

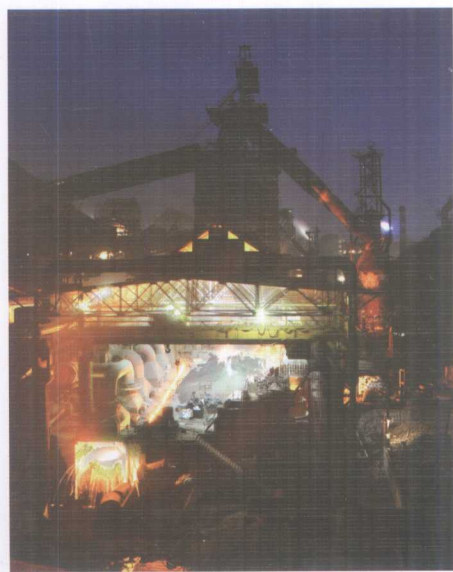

首钢水城钢铁（集团）有限责任公司（下文简称水钢）始建于1966年，是由首钢控股，以钢铁制造业为主，集采矿、煤焦化、机械加工、建筑安装、汽车运输、水泥、进出口贸易等多种配套产业为辅的大型钢铁联合企业。资产总额115亿元，在岗职工1.99万人，主体设施具备年产280万吨生铁、300万吨钢、300万吨钢材综合生产能力，排名“中国企业500强”第343位、“中国制造业500强”第190位，并多次荣获“全国五一劳动奖状”、“全国先进基层党组织”、“全国质量工作先进集体”、“全国企业文化优秀奖”、“全国群众体育先进单位”等荣誉称号。

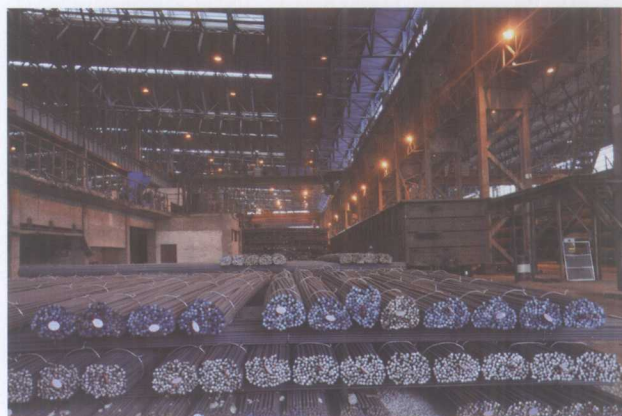

The total assets of 11.5 billion yuan, 1.99 million workers in the post, the main facility with an annual output of 2.8 million tons of iron, 300 tons of steel, 3 million tons of steel production capacity, ranking the 343rd of the "China Top 500 Enterprises", 190th of the "China's manufacturing sector 500", and has won the "National Labor Award", "National Advanced grass", "National Quality collective work of art", "National Culture Award of Excellence", "National Advanced Unit of mass sports" Honor.

Dec. 27, 2010, Guangdong and Guizhou Provincial Government signed <The Frame Agreement on Power Transmission From Guizhou to Guangdong during The 12th Five-Year> with China Southern Power Grid Co., Ltd

贵州电网公司是中国南方电网公司全资子公司，负责贵州电网的投资、建设和经营管理，承担着输配电管理、电力购销、电力市场与调度、电力优化配置等业务。供电面积17万平方公里，服务人口3900万，下辖电力销售、设计、施工、科研等23家单位。目前贵州电网已形成500千伏“日”字型环网，并以500千伏“五交两直”输电通道与南方主网并联运行，黔电送粤能力达到800万千瓦以上，加上外送周边省区，外送能力已达900万千瓦以上。2010年底公司资产总额522亿元。

“十一五”时期，贵州电力发展成就令人瞩目。2010年末统调装机规模达2830万千瓦，较2005年末的1320万千瓦增长214.39%；售电量从2005年的557亿千瓦时增长至2010年的1091亿千瓦时，年均增长率14.39%；黔电送粤累计1587亿千瓦时，是“十五”时期的4.7倍。以电力为主的能源工业实现增加值占全省规模以上工业增加值的35%，电力工业成为贵州最大的支柱产业。

“十一五”时期贵州电网公司累计完成投资402亿元，220千伏及以上电网县城覆盖率从“十五”末的36%提升到58%。城市用户年平均停电时间从28.33小时下降到15.49小时。解决10.69万户无电户用电问题，实现全省电网覆盖范围内“户户通电”。贵州电网公司在全国率先实现以实测煤耗为基础进行火电调度。发电标煤耗减少29克标准煤/千瓦时，累计节约标煤341万吨，减少二氧化碳排放1063万吨，减少二氧化硫排放373万吨。

“十二五”期间，贵州电网公司将围绕省委、省政府加速发展、加快转型、推动跨越的“十二五”发展的主基调和工业强省战略、城镇化带动战略的实施，努力创建国内先进电网企业。累计将投资1000亿元实施骨干电网、农村电网升级改造、城市电网升级改造等项目和“西电东送”通道建设。至“十二五”期末，贵州计划向广东累计送电2430亿千瓦时，电网城市用户年平均停电时间不超过5小时。

Guizhou Power Grid Corporation is wholly-owned subsidiary of China Southern Power Grid Co., Ltd, is responsible for power grid investment, construction and management in Guizhou Province with business in power transmission and distribution, electricity purchase and sale, market running and dispatching, power sources optimization reallocation etc., possessing 23 subordinated-units concerning electricity sale, power design, construction and research. The service area is 170,000 square kilometers with a population of 39 million. At present, Guizhou Power Grid has formed 500 kV super high-voltage ring grid with shape of the letter "日" connected to Southern-China backbone power grid by five AC and two DC 500kV super HV lines, power transmitted capability from Guizhou to Guangdong up to 8000 MW, meanwhile above 9000 MW including to neighbor provinces. By the end of 2010, the total assets reached 52.2 billion yuan.

During the last 11th Five-Year, electric power development in Guizhou made remarkable achievement. In the service area, the total installed power generation capacity reached 28.3 GW, increased 214.39% than the end of 2005, which was 13.2 GW; amount of electricity sale increased from 55.7 TWh in 2005 to 109.1 TWh in 2010 with annual increase rate of 14.39%; cumulative electricity transmitted to Guangdong was 158.7 TWh with 4.7 times of 10th Five- Year period. The electric power sector-based energy industry added value accounted for 35% of total up- sized industry added value, and also electric power industry became the largest pillar industry in Guizhou.

In the same period, Guizhou Power Grid Corporation completed investment with a total of 40.2 billion yuan, the counties coverage of 220kV and above power grid increased from 36% in the end of 2005 to 58%. Annual average power-supplying outage time for urban end-user downed to 15.49 hours from 28.33 hours, supplied electricity to newly 106,900 end-users and distributed electricity to each household within power grid coverage. Guizhou Power Grid Corporation also took the first in the nation to actively dispatch hydro power generation output according to actually estimated thermal power coal consumption, and reduced thermal power generated-standard coal consumption by 29 grams standard coal/ kWh, cumulatively saving standard coal was 3.41 million tons, made 10.63 million tons reduction in CO2 emissions and 3.73 million tons reduction in SO2 emissions.

In the ongoing 12th Five-Year period, Guizhou Power Grid Corporation will centre efforts on fundamental policy to accelerate social development, speed up economic transformation, promote bigger stride and implementation of strategies on powerful province through industrialization, overall boost by urbanization resolved by the provincial committee of CPC and government, to build up nationally advanced power grid enterprise. Total 100 billion yuan will be invested in backbone power grid construction, rural and urban power distribution grid upgrading, and transmitted passages construction for power transmission from western to eastern in southern China. Within the 12th Five-Year, Guizhou will plan to transmit 243 TWh electricity to Guangdong, and annual average power-supplying outage time for urban end-user will be less than 5 hours.

2010年，国家开发银行贵州省分行（以下简称“贵州省分行”）认真贯彻党中央“扩内需、促发展、调结构”的方针，积极响应省委、省政府加快贵州发展的战略，积极开展工作。

发放电力项目贷款23亿元，与国电贵州公司签署100亿元银企战略合作协议。发放公路项目贷款76亿元，签订惠水至兴仁、思南至剑河、毕节至威宁高速公路项目208亿元银团贷款合同，向贵阳市域快速铁路项目及其征地拆迁工程承诺160亿元贷款。发放城镇基础设施建设贷款88亿元，在不到两个月的时间内完成了民运会80亿元配套城建项目从筛选到合同签订系列工作，并帮助贵州首次引入20亿元社保资金解决重点项目用款需求。引入中国对外建设总公司，与毕节市政府及贵州省分行签订了三方《战略合作框架协议》，通过融资模式创新，以市场化的方式解决政府公益性项目融资难题。与贵州省政府签署“十二五”时期开发性金融合作备忘录和八个专项合作协议，意向合作额度2000亿元。在支持全省重大项目的同时，积极履行社会责任，支持民生领域发展：发放保障性住房贷款8.68亿元、新农村建设贷款38.62亿元；发放助学贷款5.06亿元，帮助10.5万名学子圆了大学梦。重点支持毕节试验区建设，发放贷款13.5亿元，并促成开发银行总行专门出台了《关于支持毕节试验区发展的意见》，对毕节的发展给予信贷规模、利率等方面的优惠政策。

截至2010年末，贵州省分行管理资产余额达到900亿元，表内贷款余额700亿元，增幅均为21%；全年发放表内贷款214亿元，表外业务工作量96亿元。人民币非个人中长期贷款净增额占全省的22%，位居第一。不良贷款率0.94%。人均利润突破1000万元。各项经营指标位居全省同业前列。

In 2010, the State Development Bank of China Guizhou Branch (here in referred to as "Guizhou Branch") conscientiously implement the Party Central Committee "to expand domestic demand, promote development and structural adjustment" approach, a positive response to the provincial government's strategy to accelerate the development of Guizhou, actively put forward the work.

Power project loans issued 2.3 billion yuan, Guizhou and the National Power Corporation signed a strategic cooperation agreement between banks and enterprises 10 billion yuan. Highway project loans issued 7.6 billion yuan, signed Huishui to Xingren, Sinan to Jianhe, Bijie to Weining highway project 20.8 billion yuan syndicated loan contract, the regional express railway project in Guiyang and land acquisition projects promised 16 billion yuan loans. Distribution of urban infrastructure construction loan of 8.8 billion, in less than two months to complete the National Games 8 billion yuan to support urban construction project contract from the screening series work, and to help the introduction of 2 billion yuan in Guizhou for the first time funds to address key social security project of money demand. The introduction of China's foreign Construction Corporation, with Bijie City government and Guizhou branch signed a three-way "strategic cooperation framework agreement" by financing innovative, market-based approach to solve the financing problems of government welfare programs. And with the Guizhou provincial government signed the "Twelfth Five-Year Plan" period development finance cooperation memorandum and eight special agreement, the amount of 200 billion yuan intention to cooperate. In support of the province's major projects while actively fulfill their social responsibility to support the development of livelihood areas: affordable housing loans issued 868 million yuan, 3.862 billion yuan of new loans to rural development; student loans issued 506 million yuan to help 105,000 students get college dream. The key support to Bijie test zones, loans 1.35 billion yuan and contributed to the development head bank office issued a special "opinions on supporting the Bijie test area development", the credit scale, interest rates and other preferential policies given to the development of Bijie.

At the end of 2010, the balance of assets under management Guizhou branch reached 90 billion yuan, 70 billion yuan loan balance sheet, both an increase of 21%; annual statement of loans issued 21.4 billion yuan, off-balance sheet business workload 9.6 billion yuan. RMB non-personal term loans accounted for a net increase of 22% of the province, in the first place. NPL ratio 0.94%. Profit per capita exceeded 10 million yuan. Among the operational indicators forefront of the industry across the province.
