
致 詞





公司概况

中國煙草總公司廣東省公司成立於1983年1月1日,是根據《煙草專賣條例》對全省煙草行業產供銷,人才物,內外貿實行統一經營管理的具有法人資格的企業。

公司屬下 8 家卷煙廠,生產技術先進,效益顯著。產品的結構和質量均已進入全國同行業的先進行列,深受消費者的歡迎。 1989 年實現工業稅利比公司成立前的1982 年增長 3 倍。實現了流通暢順,供求平衡,價格平穩,產銷兩旺。全省各市、縣均已建立卷煙批發機構,14 萬個零售網點遍佈城鄉各地,同全國許多煙草行業建立了產、銷合作關係。為發展煙草國際貿易,公司設立了中國煙草進出口公司廣東分公司,在香港與廣東粵海企業 (集團)有限公司合作經營永發煙草有限公司,同世界許多國家和地區的煙草界建立了廣泛的合作關係。 公司建立了一批優質煙葉基地和卷煙輔料生產基地,煙葉和卷煙出口基地也逐步形成。公司還創辦了煙草學校,培養煙草專業人才。同時,公司與有關單位合辦了一批第三產業,正朝着多元化經營的方向發展。

CNTC Guangdong Tobacco Corporation, established on January 1st., 1983, is an enterprise with the qualification of legal person to practise centralized management and administration on production supplying, marketing, personnel, finance and internal external/trading of the tobacco industry inside Guangdong Province in accordance with the Regulations of Tobacco Monopoly in China.

Eight cigarette factories subordinated to this corporation are advanced in productive technology and remarkable in benefit; both structure and quality of their products have been among the advanced ranks of tobacco industry nationwide and have been deeply welcomed by customers. The taxes and profits achieved by this corporation in 1989 have increased three times compared with hose in 1982 i.e. before its establishment, thus carrying out smooth circulation, balancing supply & demand and stable prices; both production and marketing are brisk. Cigarette wholesale organizations have been set up in various cities and counties throughout the province with one hundred and forty thousand retail outlets spreading all over the cities and villages, and established production and sales cooperative relations with many national tobacco enterprises. For developing international tobacco trade, the corporation has set up China Tobacco Import and Export Corporation. Guang Dong Branch, founded Wing Fat Tobacco Co. Limited in co-operation with Gu ang dong Enterprises (Holding) Limited in Hongkong and established a broad co-operative relations with many internatinal and area's tobacco circles. A group of high-quality leaf tobacco and cigarettemaking auxiliary material production bases has been built. Meanwhile leaf tobacco and cigarette export bases have been shaped in steps. A tobacco technical professional school also has been established for training tobacco professional personnel. At the same time, some enterprises of the third industry will be started up to make this corporation towards the development of diversificating management.


