随着全球经济一体化的不断扩展,我国经济业已融入到了相互依存、相互渗透的世界经济大潮中。特别是我国加入世界贸易组织后,与世界各国和地区的贸易往来将会更加频繁。走向国际大市场,无疑对提高我国生产力水平及发展自身经济既是机遇又是挑战。因此,在保护民族工业的同时,提高我国产品竞争能力,使其打入国际市场,这对发展我国经济、维持国际贸易产能力,使其打入国际市场,这对发展我国经济、维持国际贸易平衡至关重要。国际上一些工业发达国家在关税大幅降低后,转而采用技术壁垒设置新的国际贸易障碍,他们利用各种技术法规、标准及合格评定程序保护本国工业。由于事先不了解国外现行技术法规而使我国出口企业蒙受巨大经济损失的情况屡有发生。国内出口企业只有事先了解国外技术法规及其变化情况,才能在产品的生产和贸易上争取主动,做到心中有数。

欧洲共同体是一个拥有三亿多人口的大市场,我国与欧共体的贸易量逐年增加,但也有一些产品因不符合欧共体技术法规要求而被迫退出欧盟市场。原则上,任何产品只有符合欧共体技术法规的要求才能进入欧盟市场。《欧共体法规目录》收集、翻译和分类整理了各种欧共体指令、决定、建议等法规题录,是一部有实用价值的检索工具书。书中所涉及的全部法规,在中国标准研究中心标准馆均有馆藏,读者利用它检索到的法规,可在标准馆得到相应的原文。此书的出版发行对我国发展国际贸易,打开欧盟这个大市场,研究国外技术法规具有积极的促进和指导作用。




