

编辑说明

一、《英国文学史及作品选读》是编者在多年教学实践基础上，根据师范院校英语专业英国文学课教学、函授教学和成人教育的实际需要而编写的英国文学教材，并经英国专家大卫·富尔顿（David Fulton）和美国专家夏绿蒂·肯奇博士（Dr. Charlotte Kinch）审阅，具有一定的实用价值。

二、该教材文史配套，既系统地概述了英国文学史各发展阶段的文学特色及代表作家，又配有选文。选文在注重思想性和艺术性的同时，还兼顾了作品的代表性和完整性。其编排顺序与文学史部分相吻合。

三、选文一律用英文注释，文字简单易懂。前四部分注释较详，五、六部分较简，以适应学生水平的逐步提高。

四、限于篇幅并考虑到作品的完整性，选文以诗歌、短篇小说、散文为主，在附录中简单介绍了十五本著名小说的梗概，供学生参考，以便有选择地阅读一、二本完整的小说，并写出读书报告。

五、每篇选文后附有思考题，以便于学生自学并启发其独立思考。

六、书后附有常用文学词汇（中英对照）及其简明释义，以及作家、作品一览表。

七、本书文学史部分是在王佩兰教授多年使用的讲义的基础上由马茜、黄际英修改和补充而成。选文注释工作除下面各位同志所分担的篇章外，其余均由马茜（1—4部分）和黄际英（5、6部分）两人完成。

序 言

英国文学是高校英语专业高年级的一门主课，对于进一步提高学生的语言水平，特别是提高他们的理解能力和鉴赏能力、扩大知识面都有非常重要的作用。虽然目前国内已有几种版本的英国文学教材，但是迄今尚未见到有适合师范院校英语专业教学需要的教材。王佩兰教授等几位主编的《英国文学史及作品选读》的出版，无疑是件非常有意义的事情。

这本《英国文学史及作品选读》至少有以下几个特点：

1. 较好地兼顾了思想性、艺术性、学术性、可读性和实用性，突出了师范院校的特点，也照顾到英语专业本科及函授教学、成人教学的需要。

2. 文史配套。这有助于把对作家作品的分析与文学史上各种思潮和流派有机地结合起来，从而加深理解作家作品在文学史上的地位和作用。

3. 注重启发性。在每篇作品后都列有思考题，这有利于学生预习和在课堂上展开讨论。

4. 注意吸收各家观点，重视介绍不同时代对作家作品及流派的不同看法，特别是当代的评论。

此外，本书的文学史部分和选文注释都用英语撰写，文字难易程度适当；书后附有十五部小说的梗概（作为学生选读原著的参考）；文学术语及简要释义；英国主要作家及其重要作品一览表。

这本《英国文学史及作品选读》是在王佩兰教授多年使用的讲义的基础上由马茜和黄际英修改和补充而成的，在多次试用中受到教师和学生们的普遍欢迎。它的正式出版，不仅是作者多年从事师范院校英语专业英国文学课教学和研究的丰富经验的结

晶，而且也是对师范院校外国文学课教学改革和教材建设的可喜尝试。相信，本书不仅可作为师范院校英语专业和大学英语专业函授的英国文学课的教材，而且也可供有一定英语基础的英国文学爱好者参考。
