

国际船舶代理行业在国际海运辅助业中占有不可或缺的位置,是承办各类航行国际航线船舶在我国港口水域的各项代理业务,并寓管理于服务的专业性涉外行业。随着我国改革开放进一步深化,国际船舶代理企业数量不断增加,到2008年10月,取得经营资质的企业已有1700余家。

根据《中华人民共和国国际海运条例》的规定,无船承运业务是指以承运人身份接受托运人的货载,签发自己的提单或者其他运输单证,向托运人收取运费,通过国际船舶运输经营者完成国际海上货物运输,承担承运人责任的国际海上运输经营活动。随着国际海运运输格局的变革,特别是为门到门全程物流提供服务的需求增加,无船承运人已正式成为国际多式联运经营人,截至2008年10月,获得无船承运人资质的企业已有3400余家。

国际船舶代理及无船承运业务的从业人员必须具有较高的综合业务素质,除具备一定的专业知识和外语水平外,还要熟知我国口岸有关法律法规及相关部门的规章制度、工作程序,并与广大货主,金融、保险行业,以及各运输部门建立广泛的业务联系。随着国际船舶代理及无船承运业务的发展,从业人员队伍也日益扩大。为促进国际船舶代理及无船承运行业健康有序地发展,不断提高从业人员的业务水平,保证我协会组织的业务培训工作更加系统和具有针对性,根据广大会员的要求,在交通运输部水运司领导的支持下,我协会邀请业内专家,特别是大连海事大学的老师参与,将多年从事理论教学和业务实践的宝贵资料整理汇总,重新编写了业务教材。同时,为方便从事国际海运相关业务人员

Unit 1 Scope of Shipping Agency Services

A shipping agency is highly proficient in providing a wide range of services all over the world. Shipping agents have been engaged in port formalities, cargo work, bunkering, ship repair, and other forms of support.

1. Agency appointment and acceptance

A shipping agent is a person or company authorized to do some acts in the name of the principal. In general, a shipping company or shipowner offers the appointment in writing. The principal or shipowner sends the agency a letter of authorization (by telegraph, telex, fax, EDI, email or other means). The shipping agency reviews the authorization and conducts a negotiation with the principal. Then, an agency agreement may be drawn up and signed after negotiation. The agency agreement specifies the scope of authorization, obligations of parties concerned, duration of the agreement, settlements of disbursements accounts, and other details. Usually, the shipping agency company confirms the acceptance of the authority to act for the principal in writing.

2. Shipping agency services

The shipping agency offers a variety of services. The services include, but are not limited to:

Entering and leaving port. Customs declarations and relevant inspections at port, requiring tug and pilot, berthing, arranging sea rescue and handling maritime affairs.

Cargo work: Arranging cargo loading and discharging, shipping

space inspection, tally, trans-shipment, stock and transport; cargo inquiry, compensation claim, handling of over-discharged cargo; issuing bills of lading on behalf of the carrier, collecting freight and settling payment for carrier, signing demurrage/dispatch agreements on behalf of the carrier and making settlements accordingly; booking shipping space for shipper and drafting relevant shipping documentation; conducting ship chartering, ship's sale and purchase, ship delivery, and signing charter party.

Supply: Fuel, fresh water, foodstuff, stores and spare parts.

Other related services: Arranging ship's checking and repair, hold fumigation, hold cleaning; consultation and information services; crew exchange/repatriation, national border exit/entry procedures, medical service, traveling service, mail service and other tasks entrusted by the shipping company and ship master.

The shipping agency represents the principal to deal with matters concerned with harbor and other authorities, maintains due contact with them and provides the shipping company with all necessary information in connection with the agency agreement.

Shipping agents attend to the procedures for vessel's entry into and departure from local ports, arrangement for pilotage, ship's berthing, Customs declaration formalities for inward and outward shipments, loading and discharging operations. They report to the shipping company or shipowner regularly on the vessel's arrival, movements and other important occurrences concerning the vessel, cargo, passengers and crew.

On behalf of the ships, agents will handle various kinds of formalities for the vessels engaged in the international transportation. The entry and departure formalities carried out by the agents are actually the handling of the documents or certificates required by Quarantine officers, Customs officers, Immigration officers and Harbor Master.

Generally, shipping agents can canvass cargo for the ship, collect freight and settle payments on behalf of the principal. They can

sign bills of lading subject to the authorization, and forward all shipping documents to shipowners after ship's sailing.

船务代理指接受船舶经营人的委托,代办与船舶有关的一切业务的人。船务代理业务范围很广,根据国际航运的习惯做法,主要包括船舶进出港业务、货运业务、船舶供应和船舶服务方面等业务 [如办理船员调换、遣返 (crew exchange/repatriation)、出入境手续等]。船方的委托(appointment)和代理人的接受(acceptance)以每船一次为限者,称为航次代理;船方和代理人之间签订有长期代理协议者,称为长期代理。
