前書

本书首先从分配与分配权、分配权与产权、 产权与产权结构、产权结构与财务主体渐进的辩证关系中分析了企业财务主体确立问题,并指出 了财务主体的基本特征,接着对国有企业财务主体的二元化进行了比较具体、深入的分析。以此 为理论基础,从财权结构、行为目标、运行机制等 方面描述了国有企业财务管理体制的改革模式, 最后,提出了保证新体制有效运行的若干政策建议。 1995 年年初,我根据所撰博士论文修订出版了《财务原理论纲——财务分配论》。在这本著作中,比较系统地研究了财务基本理论问题,并用"分配论"统驭所提出的各种新的观点。

该书出版近两年来,曾先后多次作为本科、研究生财务管理课程的教材或重要参考读物。在教学过程中,许多学生,尤其是来自实际工作中的在职研究生班的学员给我们提出了一个很有挑战性的建议:希望尽量使书中所提出的各种新的理论观点变成更具有实际可操作性的政策建议。

这个问题本身就是一个很大的难题。在今天 比较虚浮的经济理论界,这个问题似乎具有值得 引起学者们普遍思考的意义。

其实,在我撰写《财务原理论纲——财务分配论》这本理论性很强的专著时,写作的立足点还是始终站在实践这块土壤上的。在除第一章以外的其余七章,都留下了很大的空间,以期以后做理论与实践相融合的工作。《产权改革与国有企业财务管理体制的建设》,便是"论纲"中第二章"财务主体论"研究成果运用于具体,深入又系统化地分析与解决当前财务管理中一个重大现

实课题的又一次尝试。在《财务原理论纲——财务分配论》出版不久,我还以《产权改革与国有企业财务管理体制建设》的科研项目取得了湖南省科委资助的立项科研课题。近两年来,我们按课题科研计划进行了广泛的调查研究,收集资料以及专题讨论,这部即将出版的与课题同名的著作也是课题组全体同志近两年来所付心血的结晶。

在本书撰写过程中,得到了湖南财经学院财政会计系副主任郭平老师的大力支持以及理财学教研室全体老师的帮助,特致以衷心的感谢。

但愿本书的出版能为搞活国有企业这一关系到我国国民经济支柱的宏伟事业尽微薄之力。
