### 前 言

21 世纪是现代社会经济金融活动飞速发展的时代。随着中国加入 WTO, 无论是中国企业还是进入中国的跨国公司,都急需一批既懂专业又精通商务英语的人才。但商务英语自身独特的语言风格、惯用的贸易术语和规范的表达方式给商务英语学习者带来了不小的困难。为满足广大学习者的需要,我们组织了一批具有丰富教学经验,并长期从事商务英语教学的教师,在认真研究 BEC 最新考试大纲的基础上,精心编写了这本《商务英语必备词汇》,奉献给广大考生和读者。

#### 本书有两大特点:

- 1. 内容新颖,紧跟时代步伐。本书收录了商务英语领域中近7000个常用词汇及术语,并针对其主要用法给出了注释及例句。书中所有词条都是根据剑桥商务英语考试大纲,参考历年考试真题,并结合实际教学经验而汇编的,内容涉及贸易、金融、营销、企业管理、广告、法律、物流等诸多专业。本书还收录了近二三十年来商务英语领域出现的新词、新义和新用法,使之能够适用于不同层次的英语学习者。
- 2. 实用性强。本书按照字母顺序列出单词和词组,每一词条都提供详细的词性和词义,并分别给出例句。所有例句均来自真实的商务场景,力求丰富实用、真实自然、时尚规范,具有代表性和说服力,而且难易适中,兼顾多层次读者的需要。另外,每一例句均配有简明精确的中文释义,易学易懂,让读者准确地了解每个专有词汇的实际用法,使读者在学习商务词汇的同时,通过大量实用例句的输入,提高其在实际商务活动中的交际能力。

《商务英语必备词汇》博采众长、兼收并蓄,集各类商务英语词典之优点于一身,使学习者一本在手,如同身边拥有众多优秀的英语教师,可以随时解决学习和工作中出现的各类难题。本书不仅是 BEC 考试的备考工具书,也是商务从业人士掌握商务术语和商务知识的得力助手。

由于编者水平有限,书中的错漏在所难免,欢迎读者批评指正。

- acceptance credit n. 承兑信贷: Acceptance credit is a letter of credit that provides for payment by means of a time draft. 承兑信贷是指汇票到期日付款的信用证。

- accommodation endorsement n. 通融背书: Accommodation endorsement is the endorsement of a draft or other negotiable instrument by a credit-worthy party in order to enhance the instrument's acceptability in the money market. 通融背书即由信誉卓著的单位对汇票或其他可转让票据签署背书以增进票据在金融市场上的可兑性。
- accommodation paper n. 通融票据: Accommodation paper is a negotiable instrument signed by a party as maker, drawer, acceptor or endorser, without receiving value. 融通票据是一种能转让的文件,由一个个体在没有接受任何有价报酬的情况下作为出票人、受票人或者背书人签署。
- accommodation party n. 票据通融人: An accommodation party to a bill is a person who has signed a bill as drawer, acceptor, or endorser, without receiving value therefore and for the purpose of lending his name to some other person. 汇票通融人为借出其姓名与他人而在汇票上签名为发票人、承兑人或背书人,但本身并不收取代价者。

- account (s) payable (A/P) n. 应付款: Intel handles everything online, from order processing to materials management to accounts payable. 英特尔公司利用网络处理各项工作,从订单处理、物料管理到应付款。
- account (s) receivable (A/R) n. 应收款: Days receivable refer to the average number of days overdue of accounts receivable. 应收账款平均拖延日期指应收账款平均过期天数。
- account rendered n. 收款催单, 结欠清单: The treasurer made an account rendered of all the money spent. 会计做了一份关于所有开支的结欠清单。
- account sale n. 销货清单, 承销清单: We also render account sale and send you the payments. 我们也呈递了销货清单并寄给你货款。
- account year (financial year, fiscal year) n. 账户年度: Richer members pledge funds over a specific number of account year to the association. 较富有的会员保证每个财政年度向协会提供一笔特定数目的基金。
- accountable adj. 应做解释的,应付责任的: The bar steward is accountable to the beverage manager. 酒吧间服务员要对餐饮部经理负责。
- accountancy n. 会计专业,会计工作,会计学: He is studying accountancy. 他正在学习会计学。
- accountant n. 会计师, 会计人员: The accountant prepared a balance sheet for the first half-year. 会计准备了上半年的资产负债表。
- accounting n. 会计,会计工作,会计学: Jason should go in for accounting because he has a good head for figures. 杰森应从事会计工作,因为他具有计算的才能。
- accounting period n. 会计期,会计佳效期: It is especially necessary that these charges be recorded correctly if the enterprise is to determine accurately its net earnings for each accounting period. 如果企业要准确确定每一会计期的净收益,正确记录这些费用就显得特别必要。
- accounting rate of return n. 会计收益率: The accounting rate of return is calculated by dividing the average annual profits from a project into the average investment cost. 把一个项目的平均年利润分成平均投资成本即可计算出会计收益率。
- accounting report n. 会计报告, 财务报告: Shareholders have the right to

- examine the company's articles of association, minutes of shareholders' general meetings and financial and accounting reports. 股东有权查阅公司章程、股东大会会议记录和财务会计报告。
- accounting statement n. 会计报表, 财务报表: The total amount of guaranty provided by a listed company to any other party shall not exceed 50% of net assets in the combined accounting statement of the recent accounting year. 上市公司对外担保总额不得超过最近一个会计年度合并会计报表净资产的 50%。
- accounting summary n. 会计摘要,会计概要: The revenue and expense accounts are closed at the end of each accounting period by transferring their balances to an accounting summary called "Income Summary". 收入和费用账户在每个会计期末通过将其余额转入一个被称为"收益汇总"的会计摘要来结清。
- accounts n. 账目,会计部门: All questions of cost will be remitted to the officer in charge of the accounts. 所有的开销问题都要报请那位负责账目的官员同意。
- accredited adj. 经正式认可的,获委任的: Those institutes from which applicants graduated must be accredited schools or sanctioned by the Ministry of Education of P. R. C. 申请者毕业的学校须为国家正式认可的学校,或经中国教育部批准的学校。
- accrual n. 自然增长,积累: Loan classification, provisioning, interest accrual and capital adequacy rules have been tightened and brought up to international standards. 有关贷款分类、条款制定、利息自然增长、资金充足的规章条例已得到强化并达到了国际标准。
- accrual basis n. 应收应付制: To implement the matching concept correctly, the accrual basis of accounting is generally used for merchandising enterprises. 为了正确执行对应概念,商业企业会计普遍使用应收应付制。
- accrual of interest n. 应计利息,利息积累: Accrual of interest is the accumulated coupon interest, paid to the seller of a bond by the buyer (unless the bond is in default). 应计利息是指累积的息票利息,由债券的买人者付给卖出者(除非契约未得到履行)。
- accrue v. 通过自然增长或积累而产生或形成: Ability to think will accrue to you from good habits of study. 有了良好的学习习惯,你的思考能力就自然会有所增强。
- accrued benefits n. 应计退休金, 养老金: US \$ 139.5 million in deferred money had accumulated over Mr. Grasso's 36-year career at the NYSE, of

- which US\$51.6 million from accrued benefits. 格拉索先生已在纽约证券交易所工作了36年,期间共积累了1.395亿美元的延迟付款收入,其中,5160万美元来自应计养老金。
- accrued charges n. 应计费用: Financial liabilities include creditors and accrued charges. 商业债务包括贷方和各项应计费用。
- accrued costs n. 应计成本: Can non-recorded accrued costs be deducted before tax? 请问未入账的应计成本能在税前扣除吗?
- accrued dividend n. 应计股利: Accrued dividend is a regular dividend that is considered to be earned but not declared. 应计股利指本期已经发生而尚未支付的股利。
- accrued expense n. 应计费用: Accrued expense is an expense incurred, but not yet paid. 应计费用是已经发生但尚未支付的费用。
- accrued income n. 应计收益: Accrued income is income earned but neither received nor past due. 应计收益是指已经发生但未收到也未到期的收入。
- **accrued interest** n. 应计利息: Accrued interest is the accumulated coupon interest, paid to the seller of a bond by the buyer (unless the bond is in default). 应计利息是指累积的息票利息,由债券的买人者付给卖出者 (除非契约未得到履行)。
- accrued interest payable n. 应付未付利息: This account shows the amount of accrued interest payable on all indebtedness. 该账目反映了所有负债之应付而未付利息。
- accrued revenue n. 应计收入: Accrued revenue refers to revenue recognized before cash is received. 应计收入指本期已经实现,但现金尚未到账的各种收入。
- acct. n. 账目, 账户: Most married people have joint acct, so that they can each take money out when they want it. 大多数的已婚者都在银行开了共同账户,以备必要时可各自取款。
- accumulate v. 积累,累积: However, as the evidence began to accumulate, experts from the zoo felt obliged to investigate. 然而,当证据日趋增多时,该动物园的专家们感到有必要进行调查。
- accumulated depreciation n. 累积折旧: Calculate the value of the improvement by subtracting accumulated depreciation from estimated new cost. 从估计的新成本中减去累积折旧费,从而可以计算出房产的价值。
- accumulated dividend n. 累积股息: Accumulated dividend is a dividend due,

- but not yet paid, to a preferred stock holder. 累积股息是已到期但没有支付给优先股持有者的股息。
- accumulated profit n. 累积赢利, 滚存利润: Cash dividends are distributed from current earnings or accumulated profits. 现金股息来自当期收益或累积 赢利。
- accumulation unit n. 积累单位: Accumulation unit is a share of participation in a variable annuity. 积累单位指变动年金中所使用的每股的单位。
- acid test n. 酸性试验,证明真正价值的考验: Acid test is a stringent test that indicates if a firm has enough short-term assets to cover its immediate liabilities, without selling inventory. 酸性试验是一项严谨的测试,用以衡量一家公司是否拥有足够的短期资产,在无需出售库存的情况下能够支付即期债务。
- acid test ratio n. 酸性试验比率,流动资产与流动负债比率: The higher the acid test ratio, the better able is the business to pay its current liabilities. 酸性试验比率越高,企业偿还流动负债的能力越强。
- acknowledge v. 确认: Please kindly acknowledge the receipt, and have the goods sent by last motorship in September. 收到本单后请来函告知,并希望最迟于九月底以前装船为盼。
- acknowledgement n. 确认函件,回执,收货回单: I didn't receive an acknowledgement of my application. 我还没有收到申请的回执。
- acquire v. 购人,取得所有权: They used every stratagem to acquire the company. 他们想方设法占有这家公司。
- acquired surplus n. 额外收益: We have an acquired surplus of 400 million pounds. 我们有 4 亿英镑的额外收益。
- acquisition n. 购置,兼并,收买,所收购的公司: Company A is Dell's new acquisition. A 公司是戴尔新收购的。
- acquisition cost n. 收购成本,开拓业务费用: It's amazing how few companies know what their acquisition cost is. 不可思议,居然没几家公司知道他们的收购成本。
