一、《中国省市经济发展年鉴·2013（上、下）》是一部全面反映、系统比较中国区域经济和城市经济发展状况的大型统计资料性年刊。本书分为上、下册，上册收集整理了 31 个省级行政单位的数据，下册收录了 285 个地级及以上城市的数据。

二、本书信息量大、特别突出数据的发展性和比较性，包括连续三年的统计数据以及最后一年数据的位次排列，为讲述全国地区发展和城市发展提供了重要的参考依据。主要内容涵盖：行政区划与人口、就业和工资、国民经济核算、固定资产投资、财政和税收、价格指数、居民生活、城市建设、资源、能源和环境、农业、工业、建筑业、运输和邮电、贸易和旅游、金融业、房地产业、科学技术、教育、卫生、文化和体育、社会服务和社会保障等社会经济发展的各个方面。本书未包括香港特别行政区、澳门特别行政区和台湾省的数据。

三、本书所涉及东部、中部、西部和东北地区的具体划分为：

东部 10 省（市）包括北京、天津、河北、上海、江苏、浙江、福建、山东、广东和海南；

中部 6 省包括山西、安徽、江西、河南、湖北和湖南；

西部 12 省（区、市）包括内蒙古、广西、重庆、四川、贵州、云南、西藏、陕西、甘肃、青海、宁夏和新疆；

东北 3 省包括辽宁、吉林和黑龙江。

四、本书中部分数据合计数或相对数由于单位取舍不同而产生的计算误差，均未做机械调整，本书的数据均来源与国家政府机构、行业协会等公开发布数据整理而成，数据准确权威。

Editor's Notes

I. "Cina Provinces and Cities Economic Development Yearbook - 2013 (Volumes 1 and 2) " is a large statistical annual book which fully reflected and compared China's regional and urban economy development systematically. Thish book is divided into two volumes, Volume 1 collected data of 31 provincial administrative units, Volume 2 includes the data of more than 285 central cities in Chinese urban system. To facilitate readers to use, the book made brief explanation to the major statistical indicators.

II. The yearbook is informative and particularly prominent on it's developmental and comparative data which including three consecutive years of statistical data and the seating arrangement on data of the last year. It provides an important reference for comparing the national regional development and city development. The Main contents include: population and land, employment and wages, national economic accounting, fixed asset investment, national finances and taxes, price index, the lives of residents, city construction, resources, energy and environment, agriculture, industry, construction, transportation and post and telecommunications, trade and tourism, finance, real estate industry, science and technology, education, health, culture and sports, social service and social security and other aspects of the social and economic development. The data of this book does not include the Hong Kong special administrative region, Macao special administrative region and Taiwan province.

III. The regions involved in the book were divided like this: Eastern region including Beijing, Shanghai, Tianjin, Hebei, Jiangsu, Zhejiang, Fujian, Shandong, Guangdong and Hainan 10 provinces (municipalities);

Central region including Shanxi, Anhui, Jiangxi, Henan, Hubei and Hunan 6 provinces; Western region including Inner Mongolia, Guangxi, Chongqing, Sichuan, Guizhou, Yunnan, Tibet, Shaanxi, Gansu, Qinghai, Ningxia and Xinjiang 12 provinces (autonomous regions and municipalities); Northeastern region including Liaoning, Jilin and Heilongjiang 3 provinces.

IV. Some total numbers or relative numbers in this book may have a few calculation errors because of a certain units, we did not do the mechanical adjustment. Book sources of data and national government agencies, trade associations, and other publicly available data from the authority of the data accurate.
