Foreword

At the Fifth Plenary Session of the 18th CPC Central Committee in October, 2015, the “Five Major Development Concepts” of innovation, coordination, greenness, openness and sharing were put forward. In December 2015, the central government held a national urban work conference again after the elapse of 37 years, and raised the thinking of “One Regularity and Five Overall Plans” for urban work. In such background, Shanghai kicked off its new round of compilation of Shanghai Master Plan (2017-2035), and a written approval was obtained from the State Council of China in December, 2017. This new round of Shanghai Master Plan has become the action program to guide the city’s future development, and at the same time acted as a specimen of China’s Ministry of Housing & Urban-Rural Development for the promotion of a new round of master plan reform nationwide, receiving extensive attention from the whole country and even the world. Nowadays, Shanghai has taken a new step on the road of the promotion of urban development transformation by the transformation of planning.

Recalling every important historical stage of Shanghai’s urban growth, we can see the urban and rural planning of each edition has played an important role of strategic guidance. Facing the new situation of tight constraints on resources and environment, and coping with the new requirements posed by the transformation and upgrading of economic development, Shanghai planning professionals, by adhering to the principle of putting people first, have actively explored new methods and routes for urban-rural planning as well as management of land and resources; and made unremitting efforts to turn Shanghai into a “vanguard in reform and opening-up” and a “pioneer in innovation and development” in the new era. Shanghai Urban Planning Trade Association (SUPTA) holds, once every two years, an activity for selection of Shanghai excellent urban-rural planning and design, and compiles award-winning works into a series of collections, thus providing a good platform to encourage advanced models, display the image of planning workers, and promote the planning development.

This Collection of the 2015 issue assembles 103 items of works, all winning the “2015 Shanghai Excellent Urban and Rural Planning and Design Awards”, and paying close attention to a series of social hot topics, such as ecological environment protection, historical style inheritance, and the coordinated development of urban and rural areas. So, it can be said that the book is not only a concentrated expression of new concepts, new technologies and new practices in urban-rural planning in Shanghai for a certain phase, but also a record and epitome of the planning transformation in Shanghai. It is hoped that the publication of this Collection can further facilitate exchanges and mutual reference among the design institutes and planning workers, and encourage them to learn not only the advanced methods and concepts, but even more the strong sense of social mission and responsibility, and the spirit of bold innovation and practice.

The year of 2018 is the starting year for carrying through the spirit of the 19th CPC National Congress and the first year for comprehensively implementing the new Shanghai Master Plan. Standing at a new historical starting point, we hope that even more excellent planning designs will come up through our joint efforts, to help Shanghai’s construction of “Five Centers” (that is, international centers of economy, finance, trade, shipping and S&T innovation). In short, we should work hard to build Shanghai into a prominent global city of innovation, humanity and ecology, a socialist, modern and international metropolis.

序二

城乡规划具有政府公共政策属性。近年来，随着中央城镇化工作会议、城市工作会议的先后召开，城市规划建设管理工作若干意见、城市设计管理办法等文件的陆续出台，城乡规划在落实国家战略、推进城乡统筹发展进程中，承担了更高的历史责任，在城镇和广大农村地区的发展和转型中，发挥着更为重要的战略引领和刚性控制的作用。

两年一届的全国优秀城乡规划设计奖，是我国城乡规划设计领域的最高奖项。回顾2015年度上海优秀城乡规划设计奖评优活动，在市规土局领导的重视和关心下，各规划设计单位积极参与，全市共收到46家规划设计单位的240个项目，经过上海专家组认真评选，其中有92个项目榜上有名。2016年，经中国城市规划协会组织评审，最终有24个项目在全国获奖。这些不同类型规划各具特色，法定规划类项目在注重技术准则和编制规范的基础上，突出了前瞻性和操作性相结合；城市设计、专项规划等非法定规划类项目，更加注重实际需求，突出了创新探索，获奖数量和质量较往届有所提升。《上海南外滩滨水区城市设计》、《上海市金山廊下镇郊野公园规划》、《武当山风景名胜区总体规划修编（2012-2025年）》等获得全国一等奖。这些优秀项目坚持先进理念与当地实践紧密结合，充分展现了新思路、新技术和新实践，更加注重区域统筹、社会经济协调发展、生态保护、历史文化遗产等要求，集中反映了本市规划编制单位和规划工作者深入贯彻落实国家倡导的新发展理念，体现了上海规划行业阶段性的工作成果，是行业可持续发展的重要体现。

本次《作品集》有103个项目入编，涉及的规划类型多样、内容丰富，总结提炼了各类优秀规划设计作品的特色和亮点，并且延续了专家点评内容，为广大规划设计单位和规划工作者提供了一份学习借鉴和宣传交流资料，以利于进一步提高全市规划设计队伍的业务水平，不断推动行业技术进步。两年一本系列作品集的出版，已成为上海规划行业的品牌建设内容，经过广大会员单位的共同努力，也获得了较好的行业评价和社会反响。

2017年12月，国务院正式批复了上海新一轮城市总体规划。2018年1月，上海市委、市政府召开新一轮总规实施动员大会，强调要坚持以人民为中心，在迈向卓越的全球城市的进程中，把高质量发展和高品质生活作为规划实施的根本落脚点。进入新时代，上海市城市规划行业协会将一如既往，继续发挥好行业的桥梁和纽带作用，搭建好行业的交流和发展平台，更好地服务于各会员单位，不断提高广大规划师的积极性、创造性，努力为上海乃至全国城乡规划事业发展贡献一份力量。

Foreword

Urban-rural planning has the attributes of government public policy. In recent years, as the central government of China successively convened Urbanization Work Conference and Urban Work Conference, and issued one relevant document after another, such as “Some Opinions Regarding Urban Planning, Construction and Administration”, “Regulations Regarding Urban Design Management” and others, urban-rural planning has assumed a more important historical responsibility in the process of implementation of national strategy and promotion of coordinated development of urban and rural areas, and played a role of strategic guidance and rigid control in the growth and transformation of towns and vast rural areas.

The National Excellent Urban-Rural Planning and Design Award (biennial) is the highest level of prizes in the field of urban-rural planning and design in China. In the retrospect of 2015 selection and assessment for the Excellent Urban-Rural Planning and Design Award in Shanghai, due to the care of the leaders of the Shanghai Urban Planning and Land Resources Administration Bureau and to the active participation from many planning and design institutes, a total of 240 items were received from 46 planning and design units in the city, and 92 of them were listed as candidates for national prizes. After an evaluation and selection by China Association of City Planning (CACP), 24 items finally won the national awards. These different categories of planning works have their own characteristics. The statutory planning category of works highlights the combination of foresight and operability on the basis of emphasizing technical standards and compiling norms. Non-statutory planning category, including urban designs and special planning, pays more attention to actual needs and makes innovation and exploration prominent. And the number and level of the award-winning works in this category have improved over previous years. Among the national first prize winners are “Urban Design for the Waterfront Area of South Bund in Shanghai”, “Planning of the Country Park in Langxia Town, Jinshan District, Shanghai” and “Revision of the Master Plan for Wudang Mountain Scenic and Historic Area (2012-2025)”. These outstanding works adhere to the close combination of advanced concepts and local practices, give a full display to new ideas, new techniques and new practices, and focus even more on the requirements of regional coordination, harmony between social and economic development, protection of ecology, and historical

and cultural heritage. In addition, they not only collectively reflect the implementation by Shanghai's planning units and workers of the new development concept advocated by the State, but also embody the milestones achieved by the city's planning sector, an important demonstration of the sustainable development for the industry.

This Collection contains 103 items in total, involving various types of planning works with abundant contents. It has extracted and summarized the features and highlights from these excellent planning and design works and retained the traditional column of Experts' Comments, thus providing a useful learning reference and promotional materials for the majority of planning units and workers, so as to further improve the professional level of the planning and design teams of the whole city and constantly promote their technological progress in the sector. The advent of this Collection, a biennial publication in series, has become a part of the brand construction of Shanghai's planning sector, and through the joint efforts of member units, has obtained good appraisal from the planning sector and positive social response.

In December, 2017, the State Council officially approved the new round of Shanghai Master Plan. In January, 2018, Shanghai Municipal Party Committee and Municipal Government jointly convened a mobilization meeting for the implementation of the new round of Master Plan, stressing that we must adhere to the principle of putting people first, and take high-quality development and high-quality life as the foothold for planning implementation in the process of marching forward toward a prominent global city. In the new era, Shanghai Urban Planning Trade Association (SUPTA) will as in the past continue to play the role of bridge and link in the planning sector, build and maintain a good platform for exchange and development, better serve all the member units, constantly boost the planners' enthusiasm and creativity, and work hard to contribute to the development of the urban and rural planning in Shanghai and even in the whole country.
