China Telecom Group Guizhou Province Telecom Company was founded in 19th July, 2000. In the year after, Guizhou Telecom kept deepening reform, strengthening management and building itself. Aware of the West Developing Strategy and the historic opportunity of improving an informational National economy, which was proposed in the 5th of 15th session Center Party conference, Guizhou Telecom made efforts to improve its communication on one hand and to strengthen culture and ideological progress on the other hand.


