INTRODUCTION AND HOW TO USE THE DIRECTORY

Sources of Asian/Pacific Economic Information covers the region of the world extending from the Indian sub-continent to the Pacific Islands. It consists of two volumes containing in all more than five thousand entries.

The objectives of these volumes are the same as those of the companion volume, *Sources of European Economic Information*, now in its third edition: to signal the availability of statistical and economic data and to furnish the reader with the necessary direction to obtain the material. It provides not the information itself, but a synopsis and details of the issuing body.

There are differences between the countries in the Asian/Pacific directory, both in material available and in its recency of publication. For example, some countries maintain up-to-date statistics, such as the three OECD members in the region, Japan, New Zealand and Australia. But some of the developing countries rely on much older data, which would be considered obsolete in the advanced countries. In some countries there is comparatively little information, and in these cases we have included a few more general publications.

In Part One of each volume, the directory of source publications, each entry provides wherever possible the following information:

- the full title of the source publication in English
- the ordering number of the document, where relevant
- the name of the issuing body
- the language of the publication
- date or frequency of publication
- approximate number of pages
- countries covered by the source, indicated by the motor code abbreviation.
 - The international section at the beginning of Volume One covers sources relating to more than two countries.
- the purchase price
- a summary of the contents of material in the source.

Part Two of each volume presents the full name, address, and where possible the telephone and telex number, of the issuing organisations. These are arranged alphabetically by country. Each source listed in Part One has been given a unique code number, which is listed in Part Two for the publisher of that source. The divisions by country in Part Two refer to the country with which the source deals, not that where its publisher is located.

Each volume concludes with two indexes. The first lists all the sources alphabetically irrespective of country of coverage. The second provides a subject breakdown. The subject divisions in the European edition have been used as a model. Sources are listed by subject within the country covered.

The following procedure may be used to search the information base. First the reader should select the subject classification of interest. By using the second index, relevant sources for the country or countries can be identified. This will indicate the title of the source and its unique code number, which can then be located in Part One. The entry here will provide an appreciation of the type of material the source contains and the name of the issuing organisation. If the reader then wishes to obtain a copy of the source, Part Two provides details of the issuing organisation.

Each volume contains roughly half the sources, with the international sources at the beginning of Volume 1. Each volume covers a geographic area, with the exception of the international material in Volume 1, some of which ranges across the whole Asia/Pacific region. Volume 1 covers Australia, Japan, New Zealand and the Pacific Islands. Volume 2 covers the Indian sub-continent countries, the ASEAN region, and the East Asian countries including the People's Republic of China but excluding Japan.

Throughout the publication, countries are ordered by their internationally recognised motor codes. There are some countries for which no codes yet exist, and in these cases we have invented codes. The codes used are as follows:
