FOREWORD

This is the final publication of statistical tables based on the listing of establishments conducted nationwide in October-November 1975 as the preparatory phase for the 1975 Census of Establishments undertaken pursuant to Presidential Decree Nos. 418 and 733.

There are fourteen (14) tables presented which show the distribution of establishments by economic activity down to five-digit or industry level as well as by geographic area in the municipality/city level. Other tabulations of data as collated from the listing sheet, but which are not included in this publication, shall also be made available to researchers engaged in studies related to the economic development of the country.

Since the data presented here are derived before the completion of processing of census results, some discrepancies are likely to occur between this publication and the final census releases in terms of total establishment counts.

Grateful acknowledgment is due the government offices and agencies, private citizens, and our respondent establishments, in particular, for their valuable cooperation and assistance during the listing of establishments.

EXPLANATORY TEXT

The 1975 Census of Establishments is a comprehensive collection and compilation of nation-wide statistical information pertaining to the business operations of establishments in 1975.

Constituting one of the major statistical inquiries periodically undertaken by the National Census and Statistics Office, the census of establishments was preceded by those taken in 1903, 1918, 1939, 1948, 1961, 1967 and 1972.

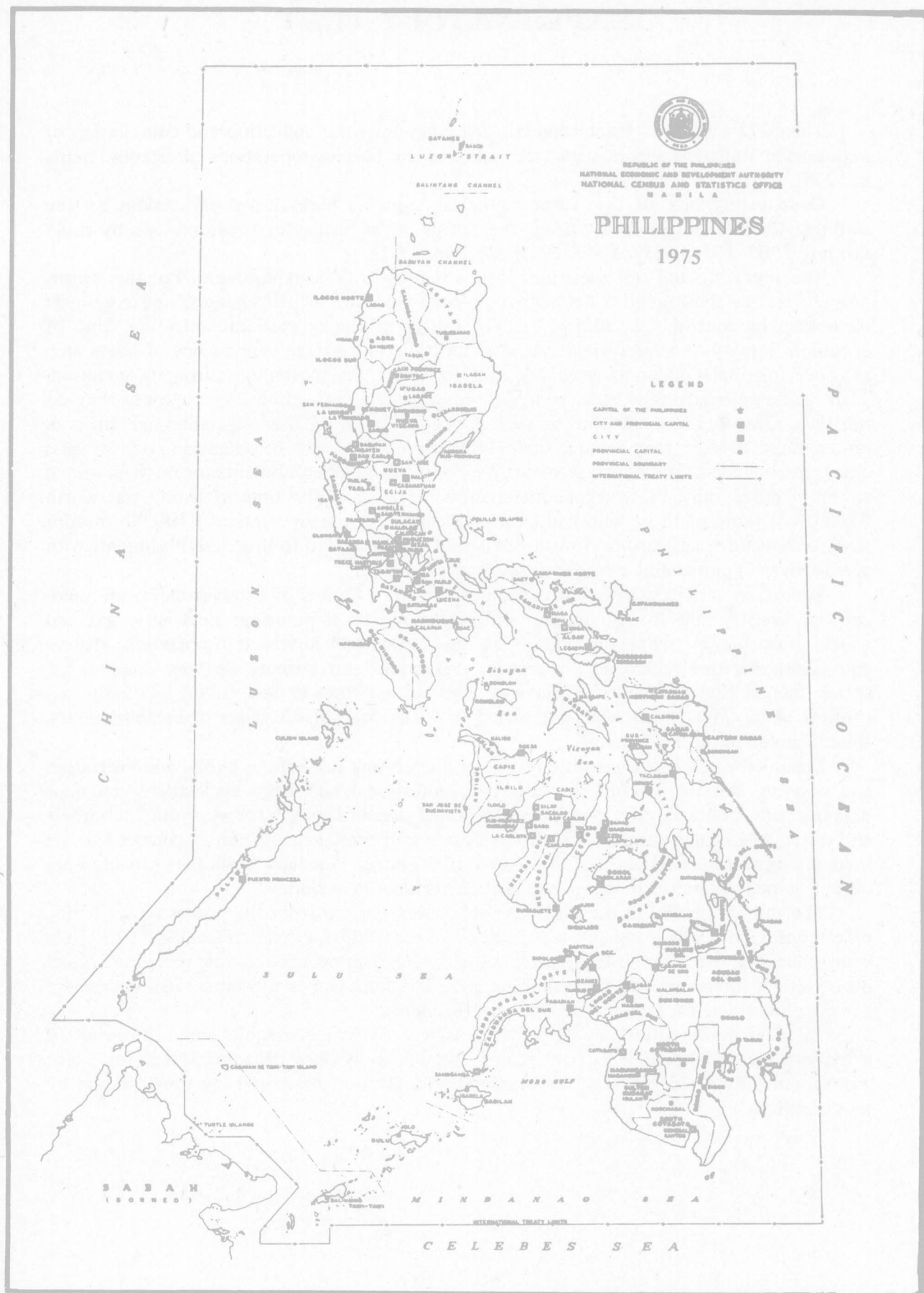
The reporting and statistical unit in this inquiry is the establishment. For this census purpose, an establishment is defined as an economic unit which engages, under a single ownership or control, i.e., under a single entity, in one or predominantly one kind of economic activity at a fixed single physical location, and having permanency of assets such as goods for resale, materials, products, equipment, etc., in its premises during its operation. Thus, self-employed individuals, peddlers, sidewalk vendors and hawkers, because they do not have fixed business location, as well as vendors of meat, fish, vegetables and fruits in rented stalls, because they remove their stocks from their place of operation after business hours are excluded. The coverage of the 1975 Census of Establishments for retail (sari-sari) stores included only those whose merchandise for sale at the time of listing was worth ₱500.00 or more or those who had an average monthly sales/receipts of ₱100.00 or more. Also, coverage for agriculture, forestry and fishing was limited to those establishments with at least five (5) permanent employees during the listing.

Economic activities within the scope of the 1975 Census of Establishments are: agriculture, forestry and fishing; mining and quarrying; manufacturing; electricity, gas and water; construction; wholesale and retail, restaurants and hotels; transportation, storage and communication; financing, insurance, real estate and business services; community, social, recreational and personal services. Agriculture, forestry and fishing (with the exception of logging) which were not included in the previous Censuses of Establishments, were included in the 1975 listing.

Excluded from this census are letting and operating real estate; public administration and defense; welfare institutions; business, professional and labor associations; religious organizations; political, civic, social and fraternal organizations; authors, music composers and other independent artists; libraries, museums and similar institutions; domestic (household services); international and extra-territorial bodies. Ancillary units that provide non-durable goods or services to parent establishments are also excluded.

The data presented in the fourteen tables were derived from the results of the listing of establishments which constituted Phase I of the 1975 Census of Establishments. Data were collected from the listing sheets which were accomplished by census enumerators during direct interview with the establishments. The complete establishment listing provides the sampling frame for selecting sample establishments.

Tabular presentations are by activity as well as by geographic area. The levels of activity presentation are 1-digit for major division, 2-digit for division, 3-digit for major group, and 5-digit for industry. Geographic presentation is by region, by province and by municipality.
