I. IN GENERAL

§ 1. Scope.—This article deals with the various kinds or classes of contempt; the power or discretion of the legislature and of judicial bodies to punish for contempt; what persons may be punished; acts or conduct which constitute contempt; contempts by particular classes of persons, such as witnesses and attorneys; the nature and extent of punishment which may be imposed; defenses to or excuses for contemptuous conduct; the procedure to be followed in adjudging and punishing for contempt; and the review of contempt
