Preface

Jin Renging

In the last few years, guided by the scientific development view, our finance department at all levels earnestly carried out each significant decision-making and its deployment made by central government. They followed closely the working thought of "1234", served for the overall situation, made the fiscal cake bigger and bigger, adhered to the people-oriented outlook, and supported forwardly the implementation of various specific reforms. With these efforts, the nation's public finance reform and development has obtained new achievements which are in favor of handling matters vital to the national economy and the people's livelihood, and serving effectively for stablizing the overall situation of reform and development. These achievements can be summed up as follows: the fiscal cake has got bigger and bigger, the national fiscal revenue has continued to realize great-leap-forward development, and so national fiscal strength has been getting stronger day by day; the national fiscal policy has been suc-



cessfully transformed, the fiscal macro-control experiences has been further accumulated, and so the sound and rapid development of the national economy has been promoted; all the tax on agricultural products has been cancelled, the fiscal policy frameworks to support agriculture has begun to establish, the public financial sunlight has more and more bathed the countryside; the intergovernmental payment transfer effect has been intensified, the mechanism of alleviating county and township fiscal difficulty has been innovated, and so the interregional coordinated development and the equalization of basic public service has been promoted; the fiscal expenditure structure has been adjusted and optimized unceasingly, the national capital has been more inclined to financing the compulsory education, financing the public health, financing the social security, financing the environment protection, etc. and so the balanced development between economic and social undertakings, and the harmonious development between man and nature have been strengthened; The innovation of the export tax rebates mechanism has produced a marked effect, the VAT reform has put it over in the pilot area, the reform of unifying the two income tax laws has gone on wheels, other tax reform has been steadily pushed forward; the budgetary management system reform has been comprehensively deepened,



the public finance system has been continuously improved; external financial exchange and cooperation has entered upon new phase, the domain of managing financial affairs has been profoundly exploited, the international standing of Chinese public finance has risen still further.

All these achievements should be owned to the correct overall leadership of the state council and the Central Committee of the Communist Party of China (CCCPC). Meanwhile, they are results of vigorous supports from various regions and sectors, and cannot be detached from the unremitting endeavor of all our financial workers either.
