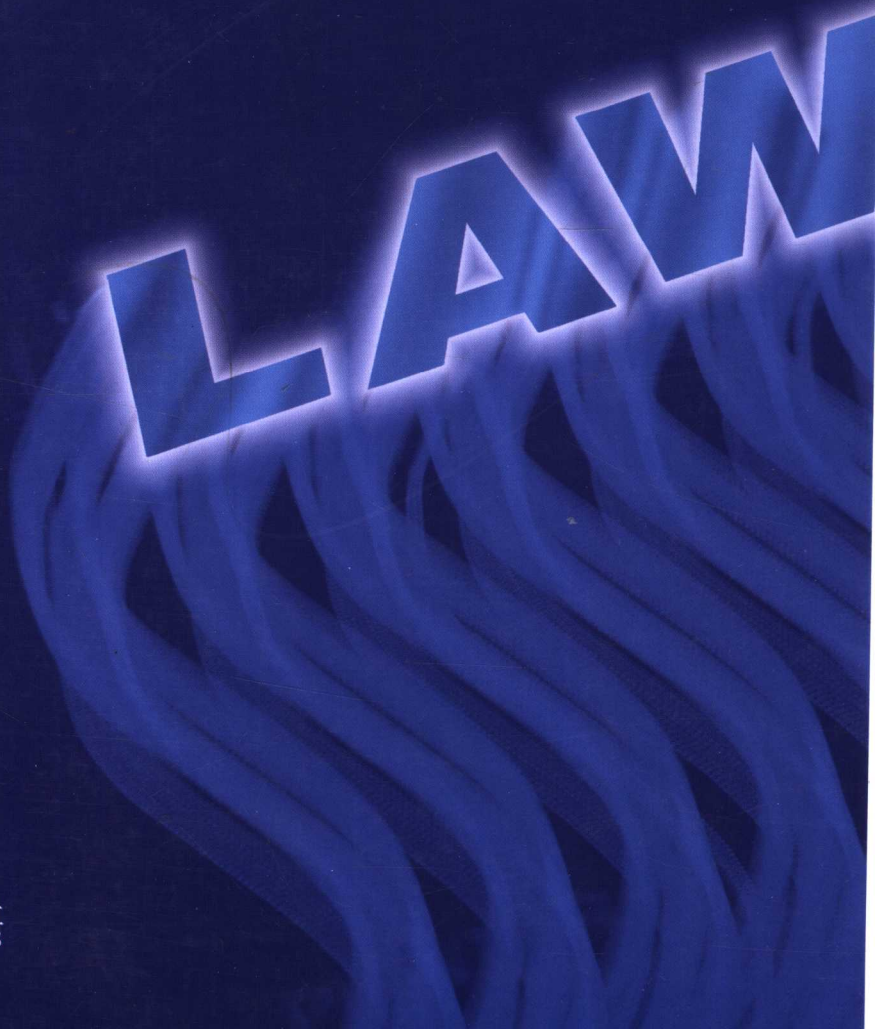

出版说明

《国际经济法学资料新编》是由中国国际经济法学会会长、厦门大学法学院陈安教授主持编纂的综合性参考资料读物。如所周知,国际经济法是新兴的、多门类、跨学科的边缘性和综合性法律部门,它所涉及的资料范围广泛,数量繁多,形式各异。目前的国内法学著作在论述时对有关资料多有引据或转述,但一般读者难以查索对照原始资料的全文或全译。为适应社会急需,本书特在较大范围内较为系统地择要选编有关的国际公约、国际惯例和其他国际性的法律文件,以便读者掌握第一手资料,联系实际,扩大探索,加深理解。全书共约 200 余万字,分为上、下两册。

本书由陈安、房东、程红星、王中美负责选编。在分类体例上,参照陈安教授主编的《国际经济法学》(第四版)(北京大学出版社 2007 年版),相应地分为十个部分,即国际经济法总论、国际贸易法、国际知识产权保护与技术转让法、国际投资法、国际货币金融法、国际税法、国际海事法、国际经济组织法、国际经济争端解决法以及世界贸易组织(WTO)争端解决成案汇编十个部分。

WTO/DSB 成立并正式运作已经十余年,其已经终局裁断的各类成案具有重大的参考价值。但各案文档繁篇浩帙,普遍查索和广泛通读,颇为不易。有鉴于此,特将 WTO 官方网站发布的“WTO 争端解决案件最新概览”(Update of WTO Dispute Settlement Cases)中“专家组和上诉机构成案简介”(Completed Panel and Appellate Body Review)部分的内容译成中文,收辑为本书第十编,便于读者通过浏览,初步了解迄今 WTO 争端解决机构已经审结的各案的基本案情及审理概况。在此基础上,读者可根据各自的实际需要和阅读能力,“按图索骥”,进一步查阅相关案件的专家组报告全文和上诉机构报告全文。

本书收辑的资料,主要取自国内公开出版发行的书刊和互联网上若干政府和国际组织的官方网站,并在篇末逐一注明了资料来源。对于所辑资料的原译者、原出版社或原网站,我们谨此表示深切的谢意。

本书所收辑的各类法律文献、文件,有中文正式文本的,即以之为准;没有中文正式文本的,则大多采用国内较为通行的译本,编者仅对个别词句作了认为必要的改译,并在相关脚注“①、②……”中列明原文和原译,以便读者进一步对照

和查核;也有少量文献由编者组织人员另行翻译。本书还收录了若干英文原文文献,供有阅读能力的读者参考。

由于编者水平所限,加之时间匆促,难免有错漏之处,期待读者及时指正,俾便日后再版时订正。
