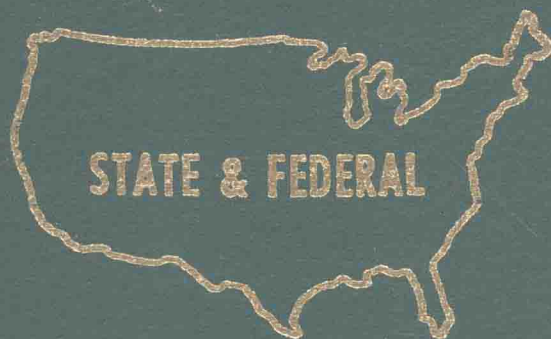

**Scope of Topic:** This article discusses the nature and powers of the United States Government in general.
