前 言

国际航行船舶的理货工作是我国对外贸易和国际海上货物运 输程序中不可或缺的一个环节。除对大宗散货实行水尺计重等特 殊计量方法外,在件杂货、集装箱货物等海上运输过程中都离不开 理货环节。国际航行船舶理货具有很强的涉外性,因此要求从业 人员具备相应的理货业务水平和英语能力。

在"计划经济"时期,国际航行船舶理货行业市场准入制度十 分严格,所以,我国从事国际航行船舶理货工作的企业很少,从业 人员相对集中,长期的实践经验也使从业人员具有了较高的业务 素质和英语水平。但是,国际航行船舶理货专业英语教材并没有 随着实践的需要而提高和发展。另外,随着我国改革开放形势的 不断发展,国际航行船舶理货行业也已经有了很大的发展。因此, 为了适应国际航行船舶理货实践发展的需要,同时也为了配合相 关专业教学的需要,我们根据国际航行船舶理货实践和从业人员 总体水平有所提高的实际情况,按照国际航行船舶理货工作程序 和主要业务内容,编写了此书。

本书分为三大部分,二十四个单元。第一部分介绍有关国际 航行船舶理货的基础知识,共有九个单元;第二部分阐述国际航行 船舶的理货业务,共有十一个单元;第三部分说明国际航行船舶理 货业务相关单证的使用,共有四个单元。

本书是专业英语教材,又是理货业务教材。因此,本书可以作 为大、中专院校理货及相关专业的英语专业教材,又可以作为理货 业务教材。本书也可作为理货人员实践的参考书。

PART I THE BASICS

SHIP TALLY INDUSTRY IN CHINA

TEXT

Any enterprise engaged in ship tally business in China must apply for an operating permit pursuant to provisions of the Port Law of P.R.C. and the Regulations on Administration of Port Operation. The permit shall be available with fixed operation sites, corresponding facilities, equipment, professional technicians and management personnel relating to the operation businesses, together with other conditions specified by laws and regulations. China Ocean Shipping Tally Company (COSTACO) and China United Tally Co., Ltd. (China Tally) have been approved to render tallying services to sea-going vessels engaged in international trade and/or domestic trade and to imports and/or exports.

COSTACO, founded in September 1, 1961, was an important state-owned backbone enterprise approved and authorized by the Ministry of Communications to specially engage in ship tally. The company became a subsidiary company of China Ocean Shipping Company (COSCO) in May 2005. Now, COSTACO has over 80 subordinate branches in the main ports, such as Dalian, Tianjin, Qingdao, Shanghai and Guangzhou, and has also set up a cargo in-

spection and supervision organization in Hong Kong.

China United Tally Co., Ltd. (China Tally) was established in 2003 and approved by the Ministry of Communications. It is a nation-wide tally company, and has its own branches at main ports of China.

Normally, tally companies provide ship tally services according to the following procedures:

For Outward Cargo

1. Before loading, the captain or his agent should furnish the tally company with relevant documents such as shipping orders and cargo plan. The tallyman should check the figures, cargo marks, packing and apparent condition.

2. During loading, the tallyman should count the packages and examine damage to cargo according to the cargo plan. Damaged cargo cannot be loaded on board. If the captain wants the cargo to be separated and dunnaged, tallyman should notify the stevedoring company duly and check it frequently.

3. When finished tallying, the tallyman should check all tally documents, count final figures of cargo loaded, make out stowage plan and other documents like the hatch list.

For Inward Cargo

1. Before discharging, the captain or his agent shall furnish the tally company with the manifest, stowage plan, etc. The tallyman should check the relevant figures, examine and deal with cargo damage and/or cargo shortage.

2. During discharge, the tallyman should count the packages and examine packing condition. Cargo damaged before discharge or during discharge should be distinguished.

3. When finished tallying, the tallyman should make out the tally papers such as overlanded/shortlanded cargo list, damaged cargo list.

If the tally company is entrusted with cargo control and tallying along with the vessel and/or tallying in both ports of loading and discharge on the same voyage, it shall be liable for ship's compensation for cargo shortage due to the discrepancy of figures from twice-tallying.

The limitation period for the entrusting party to lodge a claim and/or to bring a suit shall be within one year starting from the day of completion of tallying.
