XU Chongde was born in Qingpu, Shanghai in 1929. He received his Bachelor's Degree from the Department of Law, Fudan University in 1951, and after obtaining his Graduate Certificate, started his teaching career at the School of Law, Renmin University of China in 1953. Xu Chongde was appointed as Professor and Tutor of Doctoral Students in 1986 and has been teaching Constitutional Law at the University since then. Beginning in the late 1980s, he has been invited to lecture at the University of Macao, the City University of Hong Kong, Seoul National University, Chungang University, New York State University, Yale University, and Ritsumeikan

University. It is well known in China that Xu Chongde gave lectures on Constitutional Law for the Standing Committee of the National People's Congress in 1998 and for the first learning meeting of the Central Political Bureau of the Communist Party of China in 2002.
