EDITORIAL POLICIES AND SUBSCRIPTION INFORMATION

With this Index, the American Association of Law Libraries is making available the contents of selected legal periodicals dealing with International Law (Public and Private), Comparative Law, and the Municipal Law of those countries other than the United States, the British Isles and the British Commonwealth, whose systems of law have a Common Law basis. The Index to Foreign Legal Periodicals thus complements and, to a limited extent, duplicates other indices which provide indexing services for legal periodicals published largely in English.

The list of periodicals indexed herein has been compiled with the advice of experts in many countries, for which the Association records its thanks. The list will be kept under review, and updated in each issue. Volumes of legal essays, *Festschriften*, *Mélanges*, etc., are selected following similar procedures and policies. Although bibliographies are not normally indexed, when they appear occasionally and are significant, they are indexed under the heading "Bibliography."

Minimum length: Legal articles less than four pages in length are generally excluded, as are book reviews of less than two and one-half pages. Shorter minimums apply to folio volumes.

Titles of articles published in Eastern European languages not using the Roman alphabet are printed in the language of publication, Romanized according to Library of Congress rules. Titles in other languages not using the Roman alphabet, e.g. Oriental languages, are Romanized or are translated into English with an indication of the language of publication: [In Japanese].

Subject headings are in English. A listing of the English subject headings with extensive cross references appears on pp. 115–156. Lists of subject headings in French, German, and Spanish with corresponding English terms will be found on pp. 157–211.

Readers should be advised that letters modified by an umlaut will no longer be alphabetized as if followed by an 'e'.

The Geographical Index indicates subject headings containing articles concerned with the law of a country or countries.

The Index to Foreign Legal Periodicals is issued quarterly. Cumulations are annual, incorporating the fourth issue of the series. The annual subscription is \$450. This may be paid by Unesco book coupons. The price of Cumulation volumes will be supplied upon request.
