Keynote Speech

A TIME TO RETHINK AIR POLLUTION CONTROL*

Introduction

One beneficial result of the current energy crisis is that it is forcing us to rethink our programs, strategies, positions and attitudes in air pollution control; and, at the same time, it is allowing us a breathing spell during which to do it. If we look back in history, we find that this type of breathing spell has occurred in the past, and that, during such occasions, we have regrouped our forces, redirected our efforts and come out with better oriented and more vigorous programs than before the pause. However, this will not happen now if we just sit back and sulk. It will happen only if we use the immediate future wisely to plan the next phase of our long-term air pollution control effort.

Breathing Spells

Our present breathing spell is due to a widespread public feeling that environmental regulations were contributing to the energy crisis and, therefore should be put on the back burner until the energy picture comes into sharper focus. However, in the long run, it is hard to believe that the public will accept dirty air as the price they have to pay for energy. Once they have either
