of the first two volumes of the series. If the index is adequate, and every effort has been made to achieve adequacy, the disadvantage of having the abstracts appear in the chronological order in which they were originally printed in The Journal will, it is hoped, be considerably lessened.

## PREFACE

In 1932 a resolution was presented to the House of Delegates of the American Medical Association suggesting the advisability of publishing in book form the medicolegal abstracts that are weekly printed in The Journal of the Association. The Board of Trustees, to which the resolution was referred for consideration, reported it back with a favorable recommendation and the House of Delegates thereafter adopted the resolution.

Consideration was given to publishing a compilation of the abstracts yearly but this plan was abandoned in favor of a volume every five years. Pursuant to the authorization of the House of Delegates, the first volume was published in 1932, containing the abstracts that had previously been printed in The Journal during the calendar years 1926 to 1930, inclusive. The second volume was published in 1936, containing the abstracts that appeared in The Journal from 1931 to 1935, inclusive. The present volume represents the third in the series and includes the abstracts that have appeared in The Journal from 1936 to 1940, inclusive, all of which have been prepared by the staff of the Bureau of Legal Medicine and Legislation.

As in the case of the previous volumes, an effort has been made to prepare an adequate index to aid the user readily to find a discussion by the courts of the medicolegal problem that prompts his research. It has been suggested that the value of these compilations would be greater if the abstracts were arranged in accordance with their subject matter. Possibly this would be true. The type for the abstracts, however, is held over the five-year period and the difficulties and cost of rearrangement of such a considerable amount of type has not been justified by the limited circulation
