PUBLISHERS' NOTE

In this Consolidated Table of Cases the following rules have been adopted:

(1) ALPHABETICAL ORDER

The Table is in alphabetical order of names of plaintiffs. Where the plaintiff's name is the same in two or more cases, recourse is had to a subsidiary alphabetical arrangement consisting of the names of the defendants in these cases, return being made to the original alphabetical order of plaintiff's name as soon as a new plaintiff's name appears. Where a name consists of more than one word, the method adopted in telephone directories is followed (eg *John Walker Ltd* comes before *Johnson*).

"*Ex parte*" cases, "*In the estate of*" cases and "*Re*" cases come before cases where there is a named defendant.

Cases in which *John Doe* was the nominal plaintiff, and the casual ejector was the nominal defendant (eg *Doe d Douglas v Lock*) are arranged in alphabetical order of the true defendants without regard in each case to the name of the true plaintiff. Cases in the simple form (eg *Doe v St Katharine's Dock Co*) are placed in the same alphabetical order of defendants, regardless of the fact that the true plaintiff's name is not given. The same principles apply to "*Roe d*", "*Goodright d*" and "*Goodtitle d*" cases.

Abbreviated names are inserted in the places in which they would appear if written in full.

The alphabetical order is not affected by words denoting title or rank (eg *Lord*, *Bishop*), but these have been added in parentheses. Cases with names having variations of the prefix *Mac* (eg *Mc* or *M'*) are treated for the purpose of alphabetical order as if they began with *Mac*.

(2) CITATION OF REPORTS

The dates of all cases are given in parentheses. Citations of reports are not given unless there are two or more cases of the same name and same date, when for the purpose of distinction a citation is added to each case. The abbreviations of the names of the reports in such instances are those used in vols 1-50, a list of which is given at the front of vol 1. Full citations are given in the Table of Cases at the beginning of each volume.

(3) CASES IN THE EUROPEAN COURT OF JUSTICE

Although some cases in the European Court of Justice appear in vols 1-50, all decisions by that court which are of importance in Community law are mentioned in vols 51 and 52 (EUROPEAN COMMUNITIES). For this reason, such cases are not included in this Consolidated Table but instead are to be found, listed both alphabetically and chronologically, at the beginning of vol 52.

(4) REFERENCES

Volume references are printed in bold type (eg **27**).

Paragraph references are printed in roman (eg 123).

To aid in identifying the title or titles in which a case appears, a list of the titles contained in each volume, and the paragraphs contained in each title, is set out on pp i-iii.
