He is a Fellow of the Royal Society of Canada and Comendador de la Orden del Mérito Civil.

José Álvarez Junco is Professor of History at the Universidad Complutense de Madrid, Spain. He is the author of *Mater Dolorosa: La idea de España en el siglo XIX* (2001), which won the National Essay Prize in 2002 and prizes from the Fastenrath Foundation and the Royal Academy of History in 2003. He is the co-editor, along with Adrian Shubert, of *Spanish History since 1808* (Bloomsbury Academic, 2000).



Most recently he has collaborated with José Álvarez Junco, Gregorio de la Fuente, and the late Carolyn Boyd on *Las historias de España: Visiones del pasado y construcción de identidad*, vol. 12 of the *Historia de España* directed by Josep Fontana and Ramón Villares. At present he is writing a book, *Spanish/Literature, the Historicity of a Syntagma*, on the emergence and consolidation of a national literature in Spain from the last third of the eighteenth century to the Civil War.

María Sierra is Professor of Modern History at the University of Seville. She has conducted research programs concerning the history of liberalism in the nineteenth century (as shown in *Elegidos y elegibles*). *La representación parlamentaria en la cultura liberal* (2010), and has explored the notion of political culture in several studies, foremost, *Culturas políticas: teoría e historia*, (2010) and *Las culturas políticas contemporáneas en España y América Latina*, (2014).
