PREFACE

The First Edition of this casebook was the product of a collaboration between Professor Benjamin Kaplan of Harvard and Professor Ralph Brown of Yale--two giant figures in twentieth century intellectual property law. Their book was the first casebook on copyright law. Professor Kaplan's elevation to the bench precluded his direct participation in later editions, but the casebook continued to benefit from his generous counsel. Ralph Brown remained the principal force behind six subsequent editions. I had the pleasure of working with Ralph on four of those editions.^a

Like its predecessors, this Ninth Edition is distinctive in giving substantial attention to topics related to copyright, especially unfair competition. Copyright and its many cousins--unfair competition, publicity rights, moral rights, and corners of contract--continue to expand. The frequent amendments to the Copyright Act demand discussion, and the growth of unfair competition appears relentless. The immediate consequence is that this Ninth Edition is slightly longer than the one that preceded it, which had already stretched the limits of coverage in a three-credit course. Although the book is still manageable in size, probably no course will cover every page. To help with organization, virtually all the materials on federal copyright law appear in Part I. Most of that can be covered even in a two-credit course.

Copyright law is undergoing major transformations as new technologies spawn new challenges. The technology of photocopying still eludes control even as it is supplanted by digital storage and dissemination. The "broadcast" media continue to change shape with new forms of transmission and new means of reception. Copyright law had barely digested computer programs when it was forced to confront the enormous capacity of the Internet to disseminate works of authorship. The "information superhighway" has a very high speed limit. Can the creators of works protect themselves and still keep up with the traffic? In the face of emerging technologies, can either Congress or the courts effectively secure to authors the exclusive right to their writings without undermining the ultimate purpose of the constitutional grant?

In spite of all these matters, the emphasis here remains on fundamentals. In their Preface to the First Edition, Professors Kaplan and Brown recalled Justice Story's now famous observation that copyrights, in company with patents, "approach, nearer than any other class of cases belonging to forensic discussions, to what may be called the metaphysics of the law, where the distinctions are, or at least may be, very subtle and refined, and, sometimes, almost evanescent."^b Who is an "author"? What is a "writing"? What are the exclusive rights of authors in their writings and what, on the other hand, is "fair use"? The courts continue to instruct us almost daily on all these questions.

It is impossible to predict what may come next, except to mark the obvious and portentous acceleration of the technologies that disseminate works of authorship. Meanwhile, there is a wealth of issues, some old and some new, to tantalize and entertain both students and teachers.
