出版说明

进入新世纪以来,法律教育在取得长足发展的同时,也积极酝酿和展开改革举措,将培养高素质的现代法律人才进一步列为法律教育的重要目标。为此,本社应时而变,不拘一格,力求从教材的品种上、内容上、形式上实现更大突破,为新一代法律人学取专业知识提供更好读本。

就高等学校教材而言,我们立足两种进路:全面革新旧有教材,或推出全新教材。革新旧有教材,意在选取原有教材中的精品,从内容到形式全面更新、修订,重新整合,使这些在时间流变中积淀下来的法律教育的财富,以崭新面目,继续服务于新的读者。推出全新教材,则为约请优秀作者撰写新作,精阐原理,结合实践,关注前沿,努力创造出新世纪的新经典。优秀作者,或为老一辈与盛年名家,或为新生代才俊。或革新,或全新,这些教材统为一名,名之为“高等学校法学教材”。

我们深信,中国的法律教育事业将在改革和发展中不断壮大;我们承诺,本套“高等学校法学教材”以及本社所有法律教育图书都将在发展中不断更新,不断超越。本着竭诚为法律和法律教育服务,竭诚为读者服务的宗旨,我们愿与广大读者和作者一起,共同创造法律教育出版事业、法律教育事业,以至法治事业的未来。

编写说明

面对经济全球化和科技革命的挑战，中国的法律日趋与国际接轨；我国法学教育的国际化自不待言。国家教育部因势利导，于2001年颁发《关于加强高等学校本科教学工作，提高教学质量的若干意见》，即2001年4号文件（以下简称“《意见》”），提出了十二项提升本科教学质量的举措，其中第八项举措就是积极推动国内高等学校使用包括英语在内的外国语进行教学，积极创造条件使用英语等外国语进行公共课和专业课教学。对于法律等专业，《意见》则明确要求先行一步，力争在三年内，使用外语教学课程达到所开课程的5%~10%。为此，许多高校相继尝试用英语讲授部分法律专业课，不少高校还专门成立国际学院，所有课程均用英语讲授，其中“法学概论”或“法律基础”为各个专业的公共必修课。法学自有其独特的概念体系，其中不乏艰深晦涩的专业术语，阅读中文已令人生畏，要在英文背景下讲授和学习，又缺乏英文教材，学生更容易就坠入云山雾海之中。因此编写适合全英教学的法学教材，其紧迫性不言而喻。

Concise Chinese Law(《简明中国法》)为全英文教材，采用与国际接轨的读者中心主义(reader friendly)的写作风格。全书紧扣现行部门法的逻辑体系，涵盖宪政法、民法、商法、经济法、刑法、程序法和国际法，简洁地勾勒出中国现行法律体系和基本制度。选材精当，层次分明，主次鲜明，摒弃了细枝末节的问题，读者能够在短时间内对中国法有比较全面系统的把握。为达到简约之目标，本书在体例结构、观点阐述等进行了大胆探索，或曰创新。归结起来，主要有四点：(1)每章篇首均用简短的篇幅，尤其是表格，将浩繁的立法用简洁的命题串连起来，勾勒出该领域涉及的法律法规全貌及其变迁历程，便于读者对该领域的立法先有一个总体的把握和了解，为理解和领域其后的具体制度安排做好铺垫。(2)正文引入125个精选案例，以案说法。如母亲为了抢救孩子，超速驾车，正当医生在夸奖她时，却收到警察罚款通知；国家机关招工限身高引发的平等权之争，酒店限制非驻店客人进

入花园仅用中文提示引发的民族歧视之争,海南凯立状告证监会引发的控权与打击会计造假之争,“二奶”争夺遗产引发的私权自治与权利滥用之争等,不一而足。既生动而简洁地阐释了相关法律制度,又能够启发读者深思,领悟精妙之处,举一反三。(3)设计并使用198个图表(177个表和21个图)。法学概念和法律规则可谓纷繁芜杂,运用表格和图形进行精心梳理,通过一个个简洁的主题之串连,化繁为简,简洁明了,有助于进行横向比较和研究,体味不同制度的微妙差异。(4)大胆使用规范化的缩略语,正文目录之后还配专门的缩略语目录,减少或消除了赘笔,大大节约了篇幅,读者易于阅读。

作为一项全新的事业,本系列教材能够面世,得益于法律出版社尤其是丁小宣先生的鼎力支持和西南财经大学法学院院长、教授、博士生导师高晋康博士的大力举荐。作者本人虽已走出产业经济学领域,暨南大学的云冠平教授、黄德鸿教授、副校长胡军教授和广东金融专科学校校长张丙申教授作为我的导师和恩师,仍然一如既往地给予关心和教诲,这一切我都将永志不忘,感念终生。我与暨南大学徐煊博士、刘颖博士、吕国民博士等诸位同事的讨论,使我受益匪浅。需要特别提及的是,本书接近完成之际,电脑遭受肆虐的病毒袭击,转瞬间所有的书稿全部丢失,我的两位学生张宏鹏和杨少雄同学以及广东理治律师事务所的麦允良和谢子坚先生,昼夜兼程,奋力拼搏,文稿得以挽救。否则,我可能无力承受。自然,书中一切文字责任当由我个人承担。新的事业本来就意味着有不成熟、不完善之处,本书所作上述新尝试,必然伴随着相应的风险和疏漏。如蒙方家指正,当不胜感激。
