Revised Preface for the Sixth Edition

The Preface is where the author writes why he or she has written the book, and provides embarrassing details of the deprivations suffered by him or her, and especially his or her family, whilst undergoing the self-imposed purgatory of seemingly endless days and nights putting the words on the screen, driven—nay, possessed—by the conception that it is for the better good of mankind that the book is written. Sometimes there is an interruption when the spouse produces some children to kiss/chasten, or to whom to say 'hello'/ 'goodbye'. One only finds time to comment: 'My—don't the children look small today?' The reply comes: 'No, those are your grandchildren. Our children left home during an earlier book. Would you like to play with the grandchildren?' The answer: 'Umm, yes—but perhaps later. I just have to finish this chapter!'

There follows thanks for the almost, if not entirely, unending patience of the publisher's staff and, in particular, the editor in charge—or should I say the two, or three, or four, or five editors who have been overseeing the project or counting the missed deadlines (the writing having taken so long that the earlier editors have had time to produce their own dynasty of potential book purchasers).

So, after those initial paragraphs, will I do something completely different? Nope: it's tradition, and here is my version of it.

I've taught EC and EU law for over 30 years now (and, hey, I studied it before that both at undergraduate and postgraduate levels!) and, from the beginning, I thought that there was a need for a manageable single-text course book. In 1983, there were very few on the market and there was no credible one-stop shop; now, there are a number. However, I think the original premise holds true. Throughout the years, my colleagues and I failed to recommend wholeheartedly a single text and instead we recommended a number of texts. So, to a large extent, this is why I thought the market was still there for a new mid-range textbook at that time. It was my clear belief, backed up by an awful lot of experience, that students want a single accessible book that covers the course they are taking (or at least 90 per cent of it) and which can be absorbed easily. Obviously, a few will wish to read much more widely—those who have a real interest; for them, a number of books exist and are excellent. Most students, though, simply want to pass the exam as well as they can, but with the minimum of effort—and I don't blame them: it's perfectly rational behaviour. Who can blame them when most university managements have pursued exactly the same policy for the REF, and anything else by which they may be assessed? Effort is concentrated on securing the best result in the exercise because the result is more important than the journey—that is, the end justifies the means, even if that means diverting resources from teaching to increase research output. But watch out: the era of higher student fees is starting to focus attention back on to students and rightly so—and that is the focus of this, a student textbook, pure and simple!

So, on to the book itself. I should mention the numbering policy used in the book for the treaties, even more challenging now following the entry into force of the Lisbon Treaty. For the most part, the present numbers of the Treaty on European Union (TEU)

and Treaty on the Functioning of the European Union (TFEU) only will be used, with reference in parentheses to the immediate past numbers of the pre-Lisbon EC and EU Treaties only where vital to aid understanding, and exceptionally to the old pre-Amsterdam Treaty numbers. This will be mainly in respect of case law. This sixth edition is in production at a time when, again, great and increasing uncertainty has been cast on the future progress of the EU. The elephant in the room this time is the referendum vote on the 23rd of June 2016 in which the UK electorate voted by a narrow majority to leave the EU. No book on EU law can fail to mention Brexit at a very early stage, so here I mention it. Until the UK actually leaves the EU,2 EU law will continue to apply in the UK as an inherent part of UK national law. Indeed, even after departure, it is likely that many of those laws will continue to apply and reference may well still be useful if not necessary to their EU origins in order to understand or interpret them, so knowledge and understanding of EU law after the date of departure will still be a useful if not a necessary asset for any lawyer operating in the UK. Furthermore, this book, and others on EU law, sell internationally as there is and will remain great interest in EU law from across the world, and with the English language as the modern-day lingua franca much of this interest is satisfied by teaching EU law in English with the support of EU law books also in English. I know this to be true as I teach an intensive course in EU law at postgraduate level at the Europa Institut, Universität des Saarlandes every year which regularly attracts students from around 50 countries. I roughly calculated, following my tenth year there, that I had taught students from more than 100 different countries in that time; so whether or not the UK is turning its back on the EU, much of the rest of the world is not.

The fallout from that decision continues as I write, and whilst the election campaign is on, the consequences will continue to be unclear. The most significant other change to this edition from the previous editions is the removal of the chapter on sex discrimination. Reviewers considered it not to be relevant, as the subject is not included now in many EU law courses. If, however, this proves to be an unpopular move and, in fact, incorrect, please let me know. I'll reinstate it!


The sixth edition has been revised to incorporate the numerous, nay hundreds if not thousands of individual changes throughout the book since the last edition, which in addition to new cases include:
