## PREFATORY NOTE

Legal periodicals published in the United States, and Canada, Great Britain, Ireland, Australia and New Zealand are indexed in the *Index to Legal Periodicals* if they regularly publish legal articles of high quality and permanent reference value. Yearbooks, annual institutes, and annual reviews of the work in a given field or on a given topic are also included. Articles must be at least five ordinary pages or two folio pages, and case notes, bibliographies, biographies, and notes of legislation at least two ordinary pages or one folio page in order to qualify for inclusion.

Periodical citations conform to *A Uniform System of Citation*, 13th edition, published and distributed by the Harvard Law Review Association.

Articles are indexed under subject and author. The most specific subject heading is used wherever possible. Student authors and author entries from student sections are omitted. With the exception of national surveys, annual surveys of the law of a jurisdiction or a court are indexed under the name of the jurisdiction. Annual surveys of the decisions of the higher federal courts are indexed under the name of the particular court. Individual contributions in the annual surveys are not indexed. The list of subject headings and cross references used in indexing will be found in each annual and three-year cumulative volume.

3. The Table of Cases lists cases alphabetically under both the plaintiff's and defendant's name. Cases are cited.
4. The Table of Statutes lists statutes by jurisdiction. Statutes are then cited alphabetically by name.
5. The Book Reviews section lists reviews under the name of the author, or under the title of the work if the author is unknown.
