前 言

根据国家教育部公布的全国硕士研究生入学英语考试大纲的要求,研究生入学英语考试中新增了听力考试,并且从2003年起,听力测试部分的分数将计入总成绩,占考试总分的20%。众所周知,听力是考生各项语言技能中比较弱的一项,而且在短时间内很难有较大的提高,因此,本书的编写旨在为考生提供考前训练,使之作好充分准备。

研究生英语入学考试分为四大部分,其中第一部分就是听力测试。听力测试要求考生从所听到的内容中获取事实性的具体信息,理解明确表达或隐含其中的概念性的含义,并进行判断、推理或引申,掌握说话者的意思、观点或态度。

听力试题由 Part A、Part B 和 Part C 三部分组成,共 20 小题,每小题 1 分,共 20 分,主要是测试考生理解英语口语的能力。

Part A (5 题):主要测试考生理解特定或具体信息的能力。要求考生根据听到的一段 180~220 个词的对话或独白填充表格中的空白。录音材料播放两遍。

Part B (5 题):主要测试考生理解具体或总体信息的能力。要求考生根据所听到的一段 280~320 个词的对话或独白将所给的句子补充完整或简要回答给出的问题。录音材料播放两遍。

Part C (10)题:主要测试考生获取特定信息、理解主旨要义、推测或判断说话者意图、观点或态度等的能力。要求考生根据所听到的三段录音材料(独白或对话,每段 200~320 个词),从每题所给的 4 个选项中选出最佳答案。录音材料只播放一遍。

本书试题的提问不在录音中播放,仅在试题册上印出。

由于时间和编者的能力所限,本书存在的不足和疏漏之处,恳请广大读者批评指正。

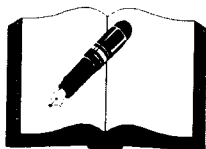
