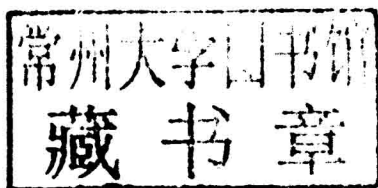

Preface to the paperback edition

For the avoidance of any doubt, this is not a second edition of this book, and thus Chapters 1–11 have remained unchanged. Chapter 12 is however new. It is a detailed analysis of the financial crisis that has dominated the EU over the past two years. The chapter begins by charting the economic and constitutional assumptions that underpinned the Maastricht settlement concerning EMU, followed by a brief explanation of the crisis itself. The discussion then turns to the responses to the crisis. These were complex and varied, but nonetheless two kinds of measure are discernible, those designed to assist Member States in economic difficulty, and those to increase supervision over national budgetary policy. These measures are analyzed, including the legal difficulties attendant upon them. This is followed by consideration of further measures that will be enacted in the light of high-level deliberations as to what is required for a 'genuine economic and monetary union'. The chapter concludes with analysis of the broader political, economic, and legal consequences of the crisis for the EU and its relationship with the Member States.
