PREFACE

THE period covered by the ten volumes of the *Annual Digest and Reports* published so far comprises the years 1919 to 1942. The present, supplementary, volume serves two purposes. The first is to put at the disposal of the reader a number of decisions, rendered in the years 1919-1942, which were omitted, or inadequately reported, on account of inaccessibility, oversight, or for other reasons. Thus this volume includes a substantial number of decisions given in the years 1940-1942 in the countries occupied by the German armed forces. It was a source of satisfaction to be able to resume contact with and to secure the continued collaboration of some of the pre-war contributors from these countries. The second object of this volume is to supply a Consolidated Index and Consolidated Tables of Cases (Reported and Cited) of the first ten volumes. It was thought desirable, notwithstanding the expense and the difficulties of publication in these days, to provide the student and the practitioner with a useful tool in handling what, by general consent, is becoming an indispensable instrument of work and reference in the field of the study and the practice of international law.

As in the past, welcome help has come from the Carnegie Endowment for International Peace. The Advisory Committee and the Editor desire to express their grateful thanks to the Trustees of the Endowment for the generous continuation of their support.

In editing this volume I received much assistance and encouragement from the Advisory Committee. In particular, I availed myself freely of the advice and active help of Judge McNair, who has read a substantial number of reports, both those which are now printed in this volume and those which it was decided not to include.

I am indebted to Messrs. Butterworth & Co., the Publishers, for their efficient and helpful co-operation. The Printers, Messrs. R. & R. Clark, of Edinburgh, and their staff have lent their usual courteous and scholarly assistance. It was a pleasure to be able to join in the warm congratulations which, in November 1946, Messrs. Clark received from all parts of the country on the occasion of the centenary of their foundation.

The compilation of the Consolidated Index covering ten volumes was an arduous task requiring more than mere clerical skill, and it was fortunate that Mrs. Gladys Lyons, B.Sc.(Econ.), was able to undertake it. Her long association with the production of the *Digest and Reports* and her thorough knowledge of its methods have enabled her to compose a Consolidated Index which, I am sure, will be appreciated by the users of these volumes. I am also much indebted to her for secretarial assistance and for reading the proof and compiling the Tables of Cases and the Index of the Supplementary Volume.

I am indebted to Mr. A. B. Lyons, M.A., LL.B., and Mr. Clive Parry, M.A., LL.B., who relieved me of the task of translating the reports of French cases.

I would also express my thanks to Mr. C. J. Staines, Assistant Librarian of the Squire Law Library, University of Cambridge, for clerical assistance and for compiling the various Consolidated Tables of Cases.
