

Richard Potz is Professor of Canon and Ecclesiastical Law at the Faculty of Law at the University of Vienna and since 2005 head of the *Department of Legal Philosophy, Law of Religion and Culture*. From 1978 to 2011, he was lecturer at the *Theologischen Hochschule Benedikt XVI* in Heiligenkreuz and since 2001 at the *Islamic Pedagogical Academy* in Vienna. Since 2004, he is head of the Postgraduate Course *Canon Law for Lawyers*.

From 1983 to 2006, he was Vice-President of the *International Society for the Law of the Eastern Churches* and from 2007 to 2011 its president. He was member of the *Pontificia Commissio Codici Iuris Canonici Orientalis Recognoscendo*.
