Ethnomethodology and Conversation Analysis are cognate approaches to the study of social action that together comprise a major perspective within the contemporary human sciences. ### Notes on Contributors

Jacquelyn Allen-Collinson is a sociologist based in the School of Sport & Exercise Science at the University of Lincoln, UK. Her current research and supervisory interests cohere around sociological and phenomenological analyses of the lived sporting body and sporting activity, particularly distance running; the impact of serious injury and chronic illness on self and sporting identity; 'identity work' and the management of disrupted identity. She is also interested in autoethnographic and autophenomenographic approaches to the sociological analysis of sporting experiences.

Steve Benford is Professor of Collaborative Computing in the Mixed Reality Laboratory at Nottingham, and is an EPSRC Dream Fellow. He won the 2003 Prix Ars Eletronica for Interactive Art, the 2007 Nokia Mindtrek award for innovative applications of ubiquitous computing, and has received four BAFTA nominations. He was elected to the CHI Academy in 2012. His book *Performing Mixed Reality* was published by MIT Press in 2011. In his spare time, he plays guitar and tenor banjo with The Phil Langran Band, and with Alamootie and the Big Jig Ceilidh Band and electric guitar with Goose McCoy.

Phillip Brooker (Brunel University) is a research assistant with MATCH (Multidisciplinary Assessment of Technology Centre of Healthcare), working in the field of user-requirements for healthcare devices. He has recently completed a Ph.D. in sociology (entitled Computerised Research Technologies in Practical Research Settings), which is a video-aided ethnomethodological account of the work of two postgraduate scientific research projects in the fields of astrophysics and electrical engineering. He spends most of his spare time collaborating with friends on various musical projects linked to the usage of virtual music studio software.

Graham Button is former Pro-Vice Chancellor for Arts, Computing, Engineering and Sciences at Sheffield Hallam University. Prior to that he was the Laboratory Director for Xerox's Grenoble and Cambridge Research Centres. He has pursued ethnomethodological and conversation analytic research since 1973, gaining his Ph.D. at the University of Manchester in 1975. He holds a Royal Yachting Association and the Maritime Coastguard Agency Yachtmaster Ocean Certificate which means that he 'is experienced and competent to skipper a yacht on passages of any length in all parts of the world'.

Andy Crabtree is a Principal Research Fellow in the School of Computer Science and IT at Nottingham University. His work focuses on the relationship between computing systems and social interaction. It exploits 'ethnography' – i.e., empirical studies of human action in context – to uncover the interactional work that animates everyday activities in the home, at work, and in play. This kind of research is used to ground systems development in the naturally occurring and naturally accountable organization of human conduct.

Paul ten Have is a retired Associate Professor in the Department of Sociology and Anthropology at the University of Amsterdam. After his retirement, he took up voluntary activities in the natural environments of sea dunes, a country estate, and polder land, including acting as a nature guide. He is the author of *Doing Conversation Analysis: A Practical Guide* (2nd ed. Sage, 2007). His current research interests concern ethnomethodology, conversation analysis, medical interaction, and research practices. His current research is in the application of phenomenology to sport. To his bemusement an article of his on the sociology of the senses was awarded a Sage prize for sociological innovation at the 2010 British Sociological Association Conference. He is still putting on over-priced running shoes daily and he is listening to Bill Evans lots.

**K.** Neil Jenkings is a researcher in the School of Geography, Politics and Sociology at Newcastle University. His current research concerns 'The social production of the contemporary British military memoir'.

Russell Kelly teaches occasionally at the University of Trier (Germany). Previously he was Senior Lecturer at the University of Central Lancashire. He was initiated into the ways of the Ethnomethodologist in the late 1970s by John A. Hughes. Since then, he has lived, worked, and fly-fished in Canada and the UK, and on the west and east coasts of the US. After returning to upstate New York in 1999, he has lived in Ithaca, noted for its waterfalls, deep gorges and isolation from urban civilization. His academic work includes studies of laboratory practices, courtroom tribunals, and the intersection between the two (court cases in which scientific evidence is featured).
