



If you fail the test, you must wait at least 30 days before you retake the exam. You may attempt the test up to three times in a twelve-month period.

Recertification

Oracle announces the requirements for upgrading your certification based on the release of new products and upgrades. Oracle will give six months advance notice when an exam version is due to expire.

#### **Exam Format**

The computer-based exams are multiple-choice tests, consisting of 50–60 questions that must be completed in 90 minutes.

y interest in Oracle certification began in 1996, when I read about the Oracle DBA certificate offered by the Chauncey Group. I found it difficult to prepare for that certification exam for two reasons: first, there was an absence of practice questions readily available; second, preparation for the exam involved reviewing

six or seven different manuals and Oracle Press books, none of which were particularly suited to the task. Judging from the response to the proliferation of titles now available in the OCP Exam Guide Series from Oracle Press, it would seem others have had similar experiences.

This book is divided into two units, the first containing preparatory material for the Oracle8i New Features for Administrators exam in the Oracle8i DBA certification track from Oracle. The first unit has six chapters, and it begins with a complete listing of all the topics tested by the exam as defined by the Oracle Certified Professional Oracle8i DBA Track Candidate Guide, a free publication available from Oracle University. Each chapter contains several discussions focusing on a particular topic or subtopic objective listed by the candidate guide. Each discussion is followed with a For Review section, listing the three or four most important concepts for you to retain from the discussion. After the review, the text will give two to six exercise questions in exam-based multiple-choice or short answer format. Following the questions you will find an answer key for those questions. Thus, you should find that you're never more than a few pages away from demonstrating what you've learned

about Oracle8i new features for the OCP exam. At the end of each chapter, you will find a short summary of what was covered in the chapter, followed by a Two-Minute Drill. The Two-Minute Drill contains another bullet list of fast facts to review as crib notes for the days leading up to your OCP exam. The chapter will conclude with 12–20 short-answer and exam-based multiple choice questions designed to help you further test your understanding of the materials you learned in the chapter.

The second unit consists of one chapter containing three full-length practice exams. Each test contains exam-based multiple choice and scenario-based questions that are designed to help you strengthen your test-taking skills for the OCP exams. You will also find answers and in-depth explanations for every question in the practice exams at the end of that chapter, along with a reference back to the exam topic and subtopic objectives from the OCP Candidate Guide. This feature should help you determine your areas requiring further improvement with pin-point accuracy.

There are two appendixes to this text. Appendix A contains materials designed to help you better understand object-relational features in Oracle8i. Appendix B contains a glossary of related Oracle database terms that might help you gain a big-picture understanding of the Oracle8i database for your continued professional growth.

# Introduction

he Oracle Certified Professional DBA certification exam series is the latest knowledge good from Oracle Corporation. Called OCP, it represents the culmination of many people's request for objective standards in one of the hottest markets in the software field, Oracle database administration. The presence of OCP on the market

indicates an important reality about Oracle as a career path. Oracle is mature, robust, and stable for enterprise-wide information management. However, corporations facing a severe shortage of qualified Oracle professionals need a measurement for Oracle expertise.

The OCP certification core track for DBAs consists of five tests in the following areas of Oracle8i: SQL and PL/SQL, database administration, performance tuning, network administration, and backup/recovery. As of this printing, each test consists of about 60 multiple choice questions pertaining to the recommended usage of Oracle databases. You have 90 minutes to take each exam. The current content of those five exams covers Oracle through Oracle8i. Obtaining certification for Oracle8i through the core track is contingent on taking and passing all five core examinations. Alternately, if you have already passed the core DBA exams for an earlier version of Oracle, you can use this book to recertify your Oracle8i expertise.

## Why Get Certified?

If you are already an Oracle professional, you may wonder, "Why should I get certified?" Perhaps you have a successful career as an Oracle DBA, enjoying the instant prestige your résumé gets with that one magic word on it. With market forces currently in your favor, you're right to wonder. But, while no one is saying you don't know Oracle when you put the magic word on your résumé, can you prove how well you do know Oracle without undergoing a technical interview? I started asking myself that question last year when Oracle certification began to emerge. I was surprised to find out that, after years of using Oracle, developing Oracle applications, and administering Oracle databases for Fortune 500 companies, there were a lot of things about Oracle I didn't know. And the only reason I know them now is because I took the time and effort to become certified.

If you're looking for another reason to become certified, consider the example of computer professionals with Novell NetWare experience in the late 1980s and early 1990s. It seemed that anyone with even a little experience in Novell could count on a fantastic job offer. Then Novell introduced its CNE/CNA programs. At first, employers were fine hiring professionals with or without the certificate. As time went on, however, employers no longer asked for computer professionals with Novell NetWare experience—they asked for CNEs and CNAs. A similar phenomenon can be witnessed in the arena of Microsoft Windows NT, where the MCSE has already become the standard by which those professionals are measuring their skills. Furthermore, with the latest economic downturn in the technology-driven U.S. economy comes the possibility of involuntary IT job changes. If you want to stay competitive in the field of Oracle database administration through those changes, your real question shouldn't be whether you should become certified, but when.

If you are not in the field of Oracle database management, or if you want to advance your career using Oracle products, there has never been a better time to do so. OCP is already altering the playing field for DBAs by changing the focus of the Oracle skill set from "how many years have you used it" to "do you know how to use it?" That shift benefits organizations using Oracle as much as it benefits the professionals who use Oracle because the emphasis is on *skills*, not attrition.

Managers who are faced with the task of hiring Oracle professionals can breathe a sigh of relief with the debut of OCP as well. By seeking professionals who are certified, managers can spend less time trying to determine if the candidate possesses the Oracle skills for the job, and more time assessing the candidate's work habits and compatibility with the team.

# How Should You Prepare for the Exam?

If you spend your free time studying things like the utility that helps you investigate the contents of your redo log, you are probably ready to take the OCP Oracle8i DBA new features exam now. For the rest of us, Oracle and other companies offer classroom- and computer-based training options to learn Oracle. Now users have another option—this book! By selecting this book, you demonstrate two excellent characteristics—that you are committed to a superior career in the field of Oracle database administration, and that you care about preparing for the exam correctly and thoroughly. And by the way, the utility that helps you investigate the contents of your redo log is called LogMiner, and it is on the OCP Oracle8i DBA new features exam. That fact, along with thousands of others, is covered extensively in this book to help you prepare for, and pass, the OCP Oracle8i DBA new features certification exam.

### **DBA** Certification Past and Present

Oracle certification started in the mid 1990s with the involvement of the Chauncey Group International, a division of Educational Testing Service. With the help of many Oracle DBAs, Chauncey put together an objective fact-based and scenariobased examination on Oracle database administration. This test did an excellent job of measuring knowledge of Oracle7, versions 7.0 to 7.2. Consisting of 60 questions, Chauncey's exam covered several different topic areas, including backup and recovery, security, administration, and performance tuning, all in one test.

Oracle Corporation has taken DBA certification ahead with the advent of OCP. Their certification examination is actually five tests, each consisting of about 60 questions. By quintupling the number of questions you must answer, Oracle requires that you have unprecedented depth of knowledge in Oracle database administration. Oracle has also committed to including scenario-based questions on the OCP examinations, and preparation material for these new questions is included in this book as well. Scenario-based questions require you not only to know the facts about Oracle, but also to understand how to apply those facts in real-life situations.

Oracle's final contribution to the area of Oracle certification is a commitment to reviewing and updating the material presented in the certification exams. Oracle-certified DBAs will be required to maintain their certification by retaking the certification exams periodically—meaning that those who certify will stay on the cutting edge of the Oracle database better than those who do not.

### The First Steps and wo blund we

It is essential that you begin your preparation for the OCP DBA certification exams by understanding the test contents. You can download the OCP Candidate Guide for the Oracle8i DBA track from the Oracle University Web site, <a href="http://www.oracle.com/education/certification">http://www.oracle.com/education/certification</a>. The Candidate Guide publishes the topic areas for each exam corresponding to chapter and section discussions in this book.

Next, understand the test interface you will encounter on exam day. Figure I-1 is contains a diagram of the actual test graphical user interface. The features of the




FIGURE 1-1. Sylvan Prometric exam interface illustration


interface are indicated in the figure. Several of the main features of the assessment test interface are explained here. The top of the interface tells you how much time has elapsed and the number of questions you have answered. There is also a checkbox in the upper left corner of the interface. You can use this checkbox to mark questions you would like to review later. In the main window of the interface is the actual production question, along with the choices. The interface generally allows the user to select only one answer, unless the question directs you to select more answers. In this case, the interface will allow you to select only as many answers as the question requests. After answering a question, or marking the question for later review, the candidate can move on to the next question by clicking the appropriate button in the lower left corner. The next button over to the left allows you to return to the previous question on the OCP exam. You can score your questions at any time by pressing the grade test button on the bottom right side. The final point feature to cover is the exhibit button. In some cases, you may require the use of an exhibit to answer a question. If the question does not require use of an exhibit, the button will be graved out.

Once you've completed all questions on the exam, the Sylvan Prometric interface will display a listing of all the answers you selected, shown in Figure I-2. The questions you marked for later review will be highlighted, and an interface will be present that guides you through review of all those questions you marked. You can also review individual questions, or simply have Sylvan Prometric grade your exam.




FIGURE 1-3. Sylvan Prometric score interface illustration

The Assessment Test indicates your performance by means of a grade window, such as the one displayed in Figure 1-3. It details the number of questions you answered correctly, along with your percentage score based on 100 percent. You will be shown a section-by-section breakdown of how you did according to the topics covered on the exam as published in the OCP DBA Candidate Guide from Oracle. Finally, a bar graph indicates where your performance falls in comparison to the maximum score possible on the exam. The OCP exam reports your score immediately after you exit the exam, so you will know right then whether you pass in a similar fashion as the assessment test. Both interfaces offer you the ability to print a report of your score.

# Strategies for Improving Your Score

When OCP exams were first released, the score range for each OCP Exam was between 200 and 800. However, Oracle has vacillated on whether to scale the OCP exam score, and has experimented lately with reporting only a raw score of the number of questions you answered correctly. The bottom line is still the same. Since there are typically 60 questions on an OCP exam, you want to make sure you get at least 75 percent, or 45, of the questions right in order to pass. Given the recent use of questions with two or even three correct answers on OCP exams, you need to be

careful to select all correct answer choices on a question or else you may not get full credit for a correct answer. There is no penalty for wrong answers. The OCP examinations required for the DBA track are listed below. The OCP DBA One of W certification exam is administered at Sylvan Prometric test centers. To schedule your OCP Exam in the United States, call Sylvan Prometric at (800) 891-EXAM. For contact information outside the USA, refer to the assessment test software. For

- 3. Oracle8i: Backup and Recovery
- 4. Oracle8i: Performance Tuning
- 5. Oracle8i: Network Administration

Some preliminary items are now identified for you to take the OCP exams. First, don't wait until you're the world's foremost authority on Oracle to take the OCP Exam. If your OCP exam is scaled as it was when the exams were first released, the passing score for most exams is approximately 650. You have to get 45–50 questions right, or about 75–80 percent of the exam. So, if you are getting about four questions right out of five on the assessment test or in the chapters (more on chapter format in a minute), you should consider taking the OCP exam.

Second, if you can't answer the question within 30 seconds, mark it with the checkbox in the upper left corner of the OCP interface for review later. The most significant difference between the OCP interface and the assessment test interface is a special screen appearing after you answer all the questions. This screen displays all your answers, along with a special indicator next to the questions you marked for review. This screen also offers a button for you to click in order to review the questions you marked. You should use this feature extensively. If you spend only 30 seconds answering each question in your first pass on the exam, you will have at least an hour to review the questions you're unsure of, with the added bonus of knowing you answered all the questions that were easiest to you first.

Third, there is no penalty for guessing. If you answer the question correctly, your score goes up ten points; if not, your score does not change. If you can eliminate any choices on a question, you should take the chance in the interest of improving your score. In some questions, the OCP exam requires you to specify two or even three choices-this can work in your favor, meaning you need to eliminate fewer choices to get the question right.

# **OCP** for the Experienced DBA

Here are some notes on taking OCP exams tailor-made for users with specific levels of expertise:

Oracle's official information about OCP Cerblication, visit http://www.oracle.com/ Advanced (3-5 years continuous Oracle DBA experience) Take the database administration exam first, then take the exams in any order you wish. This is especially recommended for readers who are more experienced with database administration, because chances are you will do well on the matters tested in that exam. Many test takers go for OCP Exam 1 on SQL and PL/SQL first, thinking it is the easiest exam. This is a trap. OCP Exam 1 asks many questions that may challenge your understanding of obscure single-row functions or complex use of PL/SQL, and we believe for this reason that OCP Exam 1 is a "weeder" exam.
