FOURTH CIRCUIT.

Comprising Maryland, Virginia, West Virginia, North Carolina, and South Carolina.

CHIEF JUSTICE MELVILLE W. FULLER, of Illinois. Appointed July 20, 1888, by President Cleveland.

FIFTH CIRCUIT.

Comprising Georgia, Florida, Alabama, Mississippi, Louisiana, and Texas.

JUSTICE LUCIUS Q. C. LAMAR, of Mississippi. Appointed January 16, 1888, by President Cleveland.

SIXTH CIRCUIT.

Comprising Ohio, Michigan, Kentucky, and Tennessee.

JUSTICE DAVID J. BREWER, of Kansas, appointed December 18, 1889, by President Harrison.

SEVENTH CIRCUIT.

Comprising Indiana, Illinois, and Wisconsin.

JUSTICE JOHN M. HARLAN, of Kentucky. Appointed November 29, 1877, by President Hayes.

EIGHTH CIRCUIT.
