PUBLISHERS' NOTE

The Consolidated Table of Statutes contains all statutes of the United Kingdom Parliament at Westminster (and of English Parliaments held there, or at other places in mediaeval times) which are mentioned in Halsbury's Laws of England (Fourth Edition), whatever their territorial application. The Table is arranged in alphabetical order. Statutes of countries other than the United Kingdom are listed at the end of the Table in alphabetical order of country.

The Consolidated Table of Statutory Instruments (set out in volume 53(2)) contains all statutory orders, rules and regulations mentioned in the work, and is also arranged in alphabetical order.

In both Tables, the references given consist of the volume number in bold type (eg **27**) and the paragraph number in light face type (eg 123). It is thus possible to find where a particular provision is dealt with without knowing the title within which it falls. However, if a number of references are given and, to avoid unnecessary searching, it would be of assistance to know which titles are being referred to, the List set out in pp i-iii may be consulted. For example, a reference to **45** 1210 can, by use of the List, be identified as relating to the title TORT.

Attention is drawn to the method of dealing with references to the names of Acts and Statutory Instruments, as opposed to particular sections, rules etc. Such references are given only where no section, rule etc is mentioned throughout the title, thus avoiding a multiplicity of unhelpful references.

The Consolidated Tables are based on the position prevailing at the time individual volumes of the main work went to press. They cannot, of course, take account of any amendments, repeals or replacements subsequent to that time. Such matters come within the province of the annual Cumulative Supplement and the Current Service, which themselves contain tables of statutes through which amendments etc can be traced.
