PREFACE

My intention in writing this book has been to provide students of medical or health care law and ethics with both a textbook and a source of relevant materials. The text should be sufficiently accessible to be useful to undergraduate students with no prior knowledge of either law or medicine, but also in-depth enough to be interesting to postgraduate students already familiar with the field. Obviously, for reasons of space, it is impossible for one book to exactly match every possible medical law curriculum, and there will inevitably be areas that some readers may wish I had covered in more depth. With such issues—for example the retained organs scandal—I have flagged up other relevant sources where more detailed analysis may be found.

Many of the subjects covered in this book are contentious and newsworthy. This makes them exciting both to teach and to study, but also means that there are likely to be many interesting new developments during the life of this book. Wherever possible, I have tried to flag-up likely future directions.

People often have strongly held views on medical law and ethics, and in this book I have included extracts which embody a number of diverse perspectives. My aim has been to explain and describe current medical law, and provide balanced analysis of the issues, not to offer my personal views. There are places where my opinions may become evident, but this should not prevent readers from forming their own judgements.

While writing this book I have acquired many debts of gratitude. To begin with, I would like to thank Jane Kavanagh at OUP, who first suggested that I should consider writing a medical law textbook, and Sarah Hyland, who has been a helpful and supportive editor.

I have learned a great deal from the students who have studied medical law with me, both at LSE and Queen Mary, and I would like to thank three in particular, who worked as my research assistants at various points during the writing of this book.
