This casebook is a sister volume to Casebook on Contract Law by W T Major. Each chapter of the casebook contains a summary of the law to enable the reader to view the cases in their context. The case reports appear in the order in which they are given in the summary. The name and year only are quoted in the summary for those cases which are further reported upon. Occasionally a case is mentioned in the summary but is not further reported upon, and for such cases a full citation is given. Since much of company law is now statutory, the summaries do not purport to be complete statements of the law, and accordingly the book should be used in addition to, and not instead of, a textbook.

The casebook includes some Scottish material which is clearly marked as such by an asterisk preceding the title of the case.

The book is intended for students taking a first course in company law as part of a BTEC or SCOTVEC HND Accounting, a degree in Accounting or Business Studies, or the various professional examinations. For law students also, the book will serve as a useful and accessible summary of case law, although it cannot substitute for systematic consultation of the law reports themselves.

- **B** list of contributories A list of persons who were members of a company within a year before the commencement of a winding up, and who may be liable in the liquidation.
- **Constructive trust** A trust which arises by operation of law where a person acquires property which he is not entitled to retain.
- **Estoppel** An admission which cannot be denied by the party whom it affects (*personal bar).
- Hiving down agreement An agreement between a company and a new, wholly owned subsidiary for the sale of that business to the subsidiary.
- **Injunction** An inhibitory writ by which a court stops or prevents an illegal or inequitable act being committed.
- Judicial Committee of the Privy Council Hears appeals from courts in certain Commonwealth countries.
- Lands Tribunal Assesses compensation for compulsory purchase of land, and the variation and discharge of land obligations.
- Misfeasance The doing of a lawful act in a wrongful manner.
- **Novation** The substitution of a new document of debt with the consent of the creditor, for an earlier document of debt.
- Personal relationship company A company which is in essence a partnership between a few persons all of whom have management rights.
- **Power of attorney** A document by which one person authorises another to act for him.
- Shadow director Defined by section 741 (1) of the Companies Act 1985 as a 'person in accordance with whose directions or instructions the directors of the company are accustomed to act'.

- Action of Furthcoming Court action by which funds or property belonging to a debtor which have been arrested in the hands of a third party are made available to the creditor.
- **Declarator** Court action seeking a decree confirming or denying the existence of a right.
- Diligence The process by which, inter alia, court decrees are implemented through the attachment of assets belonging to the debtor.
- Interdict A prohibitory order of a court to prevent a wrongful act or breach of contract occurring.
- **Judicial factor** Trustee appointed by a court to administer estates to provide protection to the beneficiaries against loss or injustice.
