

Preface

This new edition incorporates changes to the law of business premises brought about by nearly fifty new cases. Whilst there have been no major changes in this area, it was time to bring the book up to date to take into account the refinement of the law. There has also been some re-organisation, with the chapter dealing with grounds for opposing lease renewal moved forward to a more appropriate place in the text.

Mediation now plays an enormous part in the resolution of legal disputes generally but particularly in commercial landlord and tenant cases. We have therefore expanded the section dealing with mediation, so as to give much greater guidance on how to prepare, the documents that are required and what actually happens during the process.

Finally, we have a new chapter on the Telecommunications Code written by guest contributor Thekla Fellas, who is a specialist in this area at Fladgate LLP. Thekla has provided a helpful new chapter that explains clearly the core elements of the Code.
