# Constitution

I. This Society shall be known as the AMERICAN GYNECOLOGICAL SOCIETY.

II. The object of this Society shall be the promotion of knowledge in all that relates to the Diseases of Women and Obstetrics.

## Fellows

III. The Fellows of this Society shall consist of Fellows, Life Fellows, and Honorary Fellows.

The Honorary Fellows, American and Foreign, shall not exceed thirty-five.

The Fellows shall not exceed one hundred in number.

Any Fellow of the Society who has completed twenty-five years of active membership, or who becomes permanently disabled by illness or injury, or who retires permanently from active practice, having fulfilled all of his obligations, shall have the distinction of Life Fellowship. Active Fellows may be transferred upon request to Life Fellowship for other specific reasons on recommendation of the Council. Life Fellows shall retain all of their former privileges without payment of dues or the necessity of attendance at meetings. Life Fellows shall not be limited in number.

A candidate for Fellowship shall be a graduate of medicine of at least ten years' standing and shall have an interest and a demonstrated talent as a clinician, teacher, and investigator in the field of obstetrics and gynecology. He shall be proposed to the Council by two Fellows who are not members of the Council. Each proposal must be accompanied by the candidate's curriculum vitae and bibliography. After presenting a paper or a formal discussion at an Annual

Meeting, a candidate may be nominated by the Council for election to Fellowship. Candidates so nominated shall be voted upon separately by secret ballot at the Annual Meeting and a three-fourths affirmative vote of those present and voting shall be required for election.

## Honorary Fellows

IV. The power of nominating Honorary Fellows shall be vested in the Council.

No American Honorary Fellow shall be voted on at the same Annual Meeting at which his name is recommended by the Council, but at the next succeeding Annual Meeting. A Foreign Honorary Fellow may be elected by unanimous consent at the same Annual Meeting at which his name is recommended.

The election shall take place in the same manner as that of ordinary Fellows.

They shall enjoy all the privileges of other Fellows, but shall not be required to pay any fee or be allowed to hold any office or to cast any vote.

## Officers

V. The officers of the Society shall be a President, a President-Elect, a Vice-President, a Treasurer, a Secretary, and an Assistant Secretary, each to be elected annually.

The Council of the Society shall consist of these officers and four additional members. One of these additional members of the Council shall be the most recent past President. The remaining three positions shall be held by Fellows for a term of three years, one being elected each year.

All officers shall be nominated and elected in accordance with the By-laws.



The officers shall enter upon their duties immediately before the adjournment of the meeting at which they were elected and shall hold office for one year.

Any vacancy occurring between the annual meetings shall be filled temporarily by action of the Council.

All officers shall be eligible for re-election. As a rule no Fellow shall be elected for a succession of more than three one-year terms as Secretary or as Assistant Secretary. Election as Assistant Secretary does not imply succession to the office of Secretary.

### **Annual Meeting**

VI. The Annual Meeting of the Society shall be held regularly at a date to be de-

termined by the Council, and shall continue for three days, unless otherwise ordered by vote of the Society at any executive session. The sole management of the annual meetings shall be under the control of the Council subject to any action of the Society at the preceding Annual Meeting.

### **Amendments**

VII. This Constitution may be amended by a two-thirds vote of all the Fellows present at an Annual Meeting, provided that notice of the proposed amendment has been given in writing at the Annual Meeting next preceding and that the same has been printed in the notification of the meeting at which the vote is to be taken.

# By-laws

## **Presidents and Vice-Presidents**

IA. The President shall preside at all meetings and perform such duties as ordinarily pertain to the chair, and shall be ex officio chairman of the Council.

If the President is unable to preside, his duties shall be assumed by the Vice-President. In the absence of the President and the Vice-President, the Treasurer shall preside.

## **President-Elect**

IB. The President-Elect shall serve as a member of the Council.

## **Secretary**

IIA. The Secretary shall attend and record all of the meetings of the Society and the Council. When they are not in session, he shall transact their business by correspondence.

He shall prepare, arrange, and publish the program for the Annual Meeting with the approval of the Council. He shall keep all records pertaining to the membership of the Society, collect and present data on candidates to the Council, notify successful candidates of their election, and announce at each annual meeting the names of those who have ceased to be Fellows since the last report.

Through his arrangement of the scientific programs and through his right and duty to submit proposals to the Council he shall assume a major responsibility for the intellectual evolution of the Society.

## **Assistant Secretary**

IIB. The Assistant Secretary, under direction of the Council, shall be responsible for editing and publishing the transactions

(TRANSACTIONS) of all official meetings during his tenure in office.

He shall assume such additional official duties as the Secretary may delegate.

## **Treasurer**

III. The Treasurer shall receive all monies due the Society, pay all its debts, and serve as custodian for its securities. He shall make investments only on the specific order of the Council. At the end of each third fiscal year he shall submit his accounts and a record of the invested funds of the Society to a Certified Public Accountant, who shall make a formal report of audit available to the Society at its next Annual Meeting.

## **Fiscal Year**

IV. The fiscal year of the Society shall begin on the first day of April and end on the thirty-first day of March each year.

## **Council**

V. The Council shall hold two regular meetings each year, one designated as the Fall meeting and the other as the Spring meeting. The Fall meeting shall be held in October or November, the exact date and place being selected by the President. The Spring meeting shall be held on the date immediately preceding the first day of the Annual Meeting.

Special meetings of the Council may be called by the President or on the written request of at least three (3) members of the Council. Six (6) members shall constitute a quorum.

At its Fall meeting the Council shall tentatively arrange the program of the succeeding Annual Meeting, delegating the

completion of these plans to the Secretary.

A list of those proposed as invited guests shall be mailed to all Active and Life Fellows not later than three months after the Annual Meeting, in order to furnish opportunity for comment concerning their desirability as invited guests. The Council shall review all properly executed proposals and select those to be invited guests at the next or succeeding Annual Meeting; acceptance shall carry with it the obligation to present a formal paper or participate in a formal discussion. The Secretary shall notify those selected as invited guests, and he shall request those invited to present papers to submit titles and abstracts before January first. However, if an invited guest requests in writing more time for the preparation of his thesis, the Secretary may grant a deferral of one year.

The names of all candidates who have fulfilled the requirements for invited guests during the preceding three years but who have not been elected to Fellowship shall be mailed by the Secretary to all Active and Life Fellows no later than three months after the Annual Meeting for a preliminary ballot. Each candidate's name shall be accompanied by the names of his sponsors, his curriculum vitae and bibliography. The purpose of the preliminary ballot is to guide the Council at its Fall meeting in recommending those whose election seems probable and withholding the names of those whose probable rejection at the Annual Meeting is indicated.

A list of the Council's formal nominees for Fellowship, accompanied by the names of their sponsors, their curriculum vitae and bibliography of each nominee shall be sent to all Active and Life Fellows with the final program of the Annual Meeting.

The Council shall determine questions by vote, or—if demanded—by ballot, the President having a casting vote.

It shall have the management of the affairs of the Society, subject to the action of the Society at its Annual Meetings.

It shall not have power to make the So-

ciety liable for any debts exceeding in total one hundred dollars in the course of any one year, with the exception of the cost of the publication of the *TRANSACTIONS*, unless specially authorized by a vote of the Society.

It shall have the entire control of the publications of the Society, with the power to reject such papers or discussion as it deems best.

The Council shall constitute a Board of Trial for all offenses against the Constitution and By-laws, or for conduct unbecoming an honorable physician, and shall have the sole power of moving the expulsion of any Fellow.

### **Nomination and Election of Officers**

VI. Nomination of officers shall be made by a committee consisting of the two most recent ex-Presidents in a position to serve and of three active Fellows proposed and approved by the Council at its Fall Meeting.

The Chairman of the Nominating Committee shall be designated by the Council. The committee after deliberation by correspondence or by meetings shall submit a list of nominees at the following Annual Meeting.

The nominations shall be reported and posted on or before the morning of the second day of the meeting.

Any member of the Society shall have the privilege of nominating candidates at the business meeting of the Society.

The Fellows nominated as officers shall be elected by ballot.

### **Order of Business**

VII. Unless otherwise ordered by the Council or by instructions given by vote of the Society at its previous Annual Meeting, the order of business at all Annual Meetings shall be:

#### *First Day*

9:30 A.M. Address of Welcome

Response to Address of Welcome

9:45 A.M. Scientific session  
 8:00 P.M. Scientific session

#### *Second Day*

9:00 A.M. Scientific session  
 12:00 M. President's Address  
 12:30 P.M. Business session  
 7:30 P.M. Annual Banquet

#### *Third Day*

9:00 A.M. Scientific session  
 12:30 P.M. Final business session and installation of officers for the ensuing year

Only Fellows of the Society shall be present at the business session, which shall include:

1. Report of the Secretary.
2. Report of committees.
3. Report of the Treasurer, including the auditor's report.
4. Special appropriations for the ensuing year.
5. Miscellaneous business.

*Robert's Rules of Order* shall be used as a parliamentary guide in the deliberations of the Society, unless otherwise specified in the By-laws.

#### **Papers, etc.**

VIII. Application of a Fellow for participation in the formal program of the Annual Meeting shall include the title and an abstract indicating the scope and content of the proposed paper, and it shall be submitted to the Secretary before October first.

No paper shall be read before the Society which has already been printed or has been read before another body.

Not more than fifteen minutes shall be occupied by a Fellow of the Society, other than the President, in reading a paper except by unanimous consent. The paper of a distinguished invited guest of the Society shall be placed first in the evening scientific

session on the first day unless otherwise ordered by the Council.

All papers that may be read before the Society, and accepted for publication, shall become the property of the Society, and their publication shall be under the control of the Council. Such papers may be published in full in medical journals, provided that they are also printed in the TRANSACTIONS.

The original copy of every paper read at the annual meeting must be in the hands of the Secretary at the time the paper is read.

All papers shall appear in their respective journals of publication as soon as reasonably possible after the annual meeting, so that illustrations utilized may be included in the TRANSACTIONS. Should publication of an article be unreasonably delayed because of incomplete manuscript, the article may then appear in the TRANSACTIONS without illustrations or may be refused for publication in the TRANSACTIONS at the discretion of the Council.

#### **Quorum**

IX. A quorum for business purposes shall be fifteen Fellows.

#### **Decorum**

X. No remarks reflecting upon the personal or professional character of any Fellow shall be in order at the annual meetings, except when introduced by the Council.

#### **Assessments**

XI. The amount of annual dues shall be determined each year by the Society and shall be paid in advance.

Any Fellow whose subscription shall be more than nine months in arrears shall be reminded of the fact by the Treasurer in writing; in event of payment not being then made, he may, on vote of the Council, be dropped from the Society.

Each Fellow shall pay on admission an initiation fee of one hundred dollars.

He shall not be considered a Member unless the initiation fee together with the dues

and assessment for the current year shall have been paid within three months after the date of his election to membership.

The Council may, at its discretion, for good and sufficient reason, remit the dues of any Fellow.

#### **Attendance**

XII. Any Fellow who shall neither attend nor present a paper for three successive years shall, unless he offers an excuse satisfactory to the Society, be dropped from

Fellowship, but this rule shall not apply to Honorary or Life Fellows.

#### **Amendments**

XIII. Any of these By-laws may be amended, repealed, or suspended by a two-thirds vote of the Fellows present at any meeting *provided* previous notice in writing has been given at the annual meeting immediately preceding the one at which the vote is to be taken.
